Downtown Sacramento Partnership appreciates the opportunity to share our support for the Downtown Sacramento Grid 3.0 Mobility Project.

As the state's first Property-Based Improvement District (PBID) comprised of property and business owners that encompass the 66 blocks of downtown Sacramento from 16th Street to Old Sacramento, Downtown Partnership is eager to see new investment in transportation improvements and programs that improve access to our downtown core. Downtown Grid 3.0 implementation will provide significant benefits to downtown residents and visitors from across the Sacramento region.

Downtown Grid 3.0 will allow for the transformation of our existing historic grid street network to provide safer and more convenient bicycle, pedestrian, and transit travel options within our downtown core. This project's enhancements to the roadway network will provide for a more balanced street function for pedestrians, bicyclists, transit users, and motorists, especially in relation to adjacent land uses. Protected bikeways with barriers or separations between traffic will also make it easier for families and casual riders from across the Sacramento region to get downtown by trail and then venture into our thriving urban core for entertainment, food and shopping. By removing barriers to connectivity, Grid 3.0 will enhance our transportation network, attract new visitors and highlight the Sacramento region's leadership in transportation policy.

Downtown Grid 3.0 is a critical initiative as we continue building a vibrant urban core that will benefit the entire region. We urge your support and approval of a Local Partnership Program Competitive Grant for Grid 3.0.

Chair Inman and Commissioners,

The Midtown Association (MA) is writing in support of the staff recommendation to fund the Sacramento Downtown Mobility Project through the Local Partnership Program Competitive Grant Program. MA is a Property and Business Improvement District that serves 1,200 properties in the Central City of Sacramento. The strategic plan that governs MA prioritized supporting and advocating for projects that encourages visitors, employees, and residents to use alternative transportation methods. The Grid 3.0 projects being recommended do that specifically.

The Central City has an increasingly constrained transportation network. The success and growth of the city will depend on a transportation network that moves bicycles, pedestrians, transit, and vehicles efficiently. 
Chair Inman and Commissioners,
