What's Next

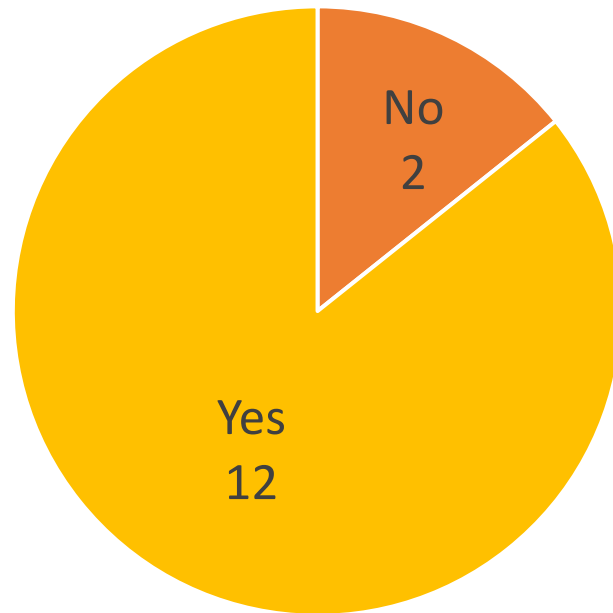
- Results from the survey and dialogue at this meeting will determine priority focus areas, educational workshop themes, and other topics for calendar year 2023 Committee focus.
- We will incorporate the results and feedback into Committee meeting agendas, educational presentations and learning materials, and research responsibilities among Committee members.



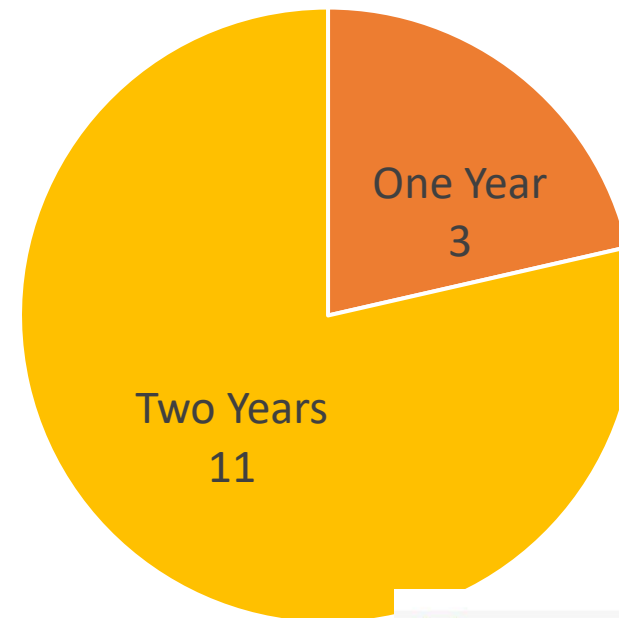


2023 Equity Advisory Committee Member Survey Results

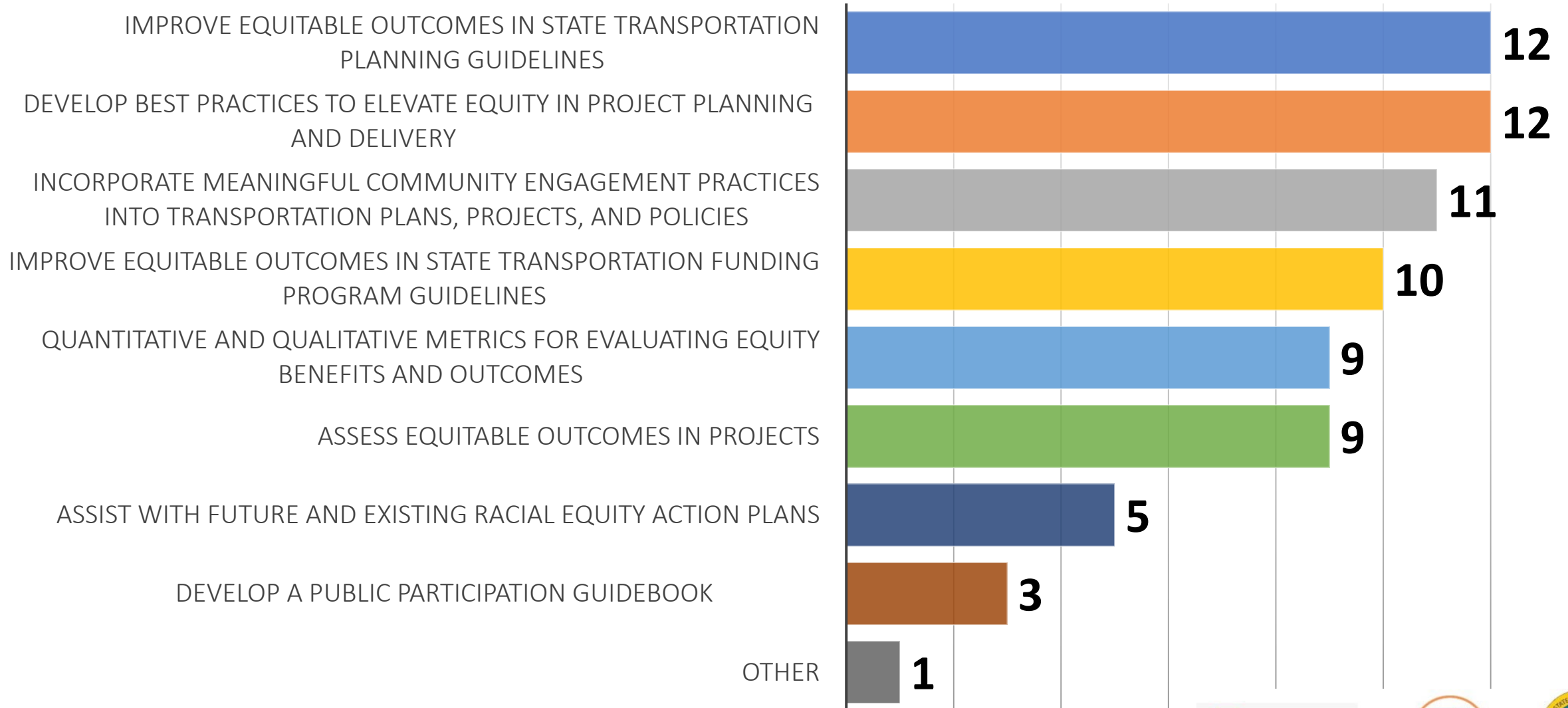
Will you be seeking compensation for your participation in this Committee?



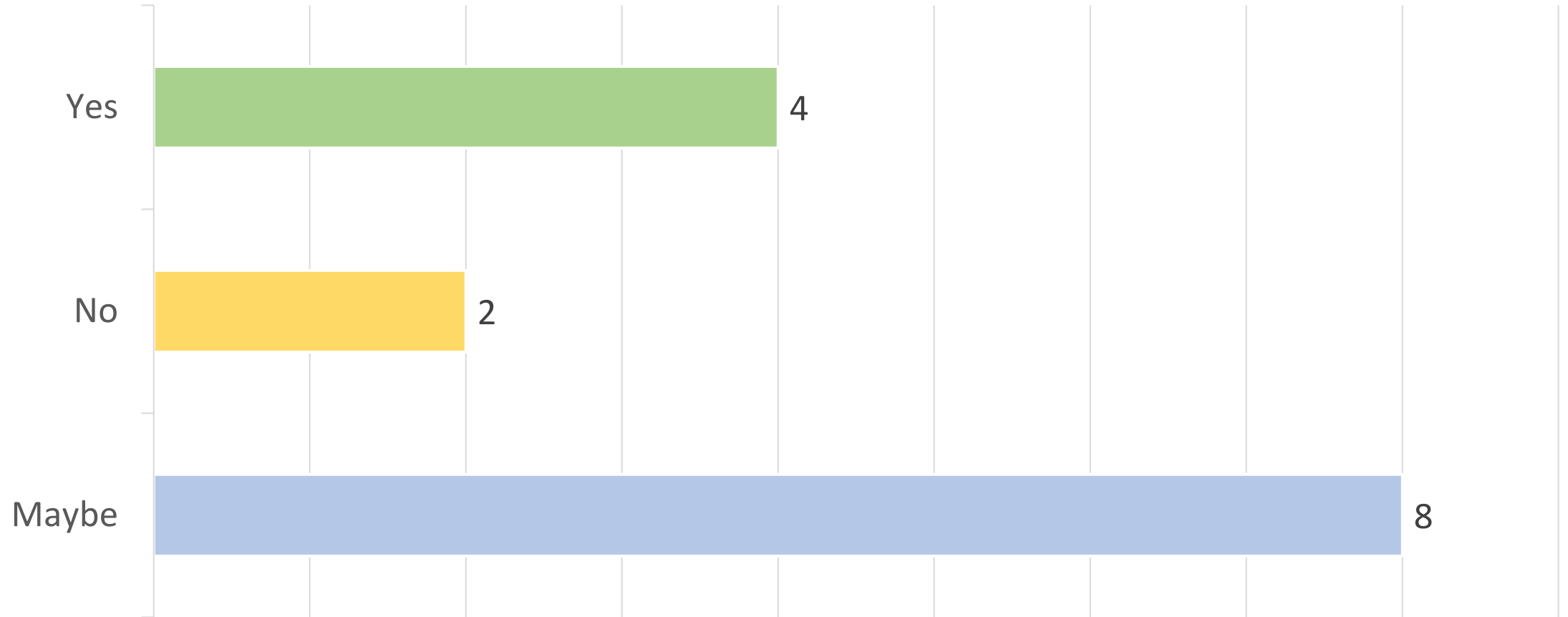
Please identify the length of time you are willing to serve
