Subject: Adoption of the 2019 Small Urban and Rural Area Federal Transit Administration Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program – Resolution G-20-30.

Issue:

Should the California Transportation Commission (Commission) approve the 2019 Small Urban and Rural Area Federal Transit Administration (FTA) Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program (Section 5310 Program)?

Recommendation:

Staff recommends the Commission adopt the attached 2019 Prioritized Program of Projects for the Section 5310 Program. The final list programs 100 percent of the estimated available federal funds for Federal Fiscal Year (FFY) 2018 and 2019, totaling \$14,248,195 as follows:

- \$8,264,444 for the Traditional Projects (capital equipment)
- \$5,983,751 for the Expanded Projects (capital equipment, operating assistance and mobility management).

The attached 2019 Project List (Attachment B), prepared by the California Department of Transportation (Caltrans), includes projects presented at the January 2020 Commission meeting subject to the following changes:

Eleven projects were added to the list; eight to the Traditional Project list and three to the Expanded Project list. These projects were miscategorized under the Large Urbanized Area Project list instead of the Small Urban and Rural Area Project list. The Large Urbanized Area category receives a separate apportionment of the Section 5310 Program and does not require the Commission's oversight.

- The miscategorized projects resulted in two projects falling below the funding level in the Expanded Project list. One of the projects moved from the Large Urban list did not score high enough for funding on the Expanded Project list, and the other project was displaced by the addition of higher scoring projects.
- Funding for six projects was reduced to minimize the impact of the additional projects added to the list.
- Two projects were removed from the Traditional Project list because they received funding from the FTA 5339 Bus and Bus Facilities Program.

Adoption of the Section 5310 Program authorizes Caltrans to fund projects in priority order, up to the federal funding estimated to be available for FFY 2018 and 2019.

Background:

The Section 5310 Program was established in 1975 and has been administered by Caltrans since its inception. It provides grants of federal funds to purchase transit capital equipment to meet the specialized needs of seniors and/or persons with disabilities for whom mass transportation services are unavailable, insufficient, or inappropriate. In 2012, Moving Ahead for Progress in the 21st Century Act (MAP-21) expanded 5310 Program funding for Mobility Management and Operating Assistance projects. MAP-21 also provided the flexibility to fund Mobility Management projects with the Traditional funding. Funding for the Traditional Program cannot be less than 55 percent of the funding available. In 2015, the Fixing America's Surface Transportation (FAST) Act maintained the funding and program flexibility made under MAP-21.

The Section 5310 Program serves a variety of client groups and programs, ranging from small agencies with specific clientele (e.g., dialysis and AIDS patients) to paratransit providers serving entire communities. Most agencies are non-profit organizations while some are public agencies where non-profit organizations are not readily available to provide the specialized service. Examples of Traditional Section 5310 projects include, but are not limited to, buses and vans; wheelchair lifts, ramps, and securement devices; transit-related information technology systems including scheduling/routing/one-call systems; mobility management programs; and acquisition of transportation services under a contract, lease, or other arrangement. The remaining 45 percent is for other "nontraditional" or Expanded projects. Under MAP-21, expanded projects include travel training; volunteer driver programs; improving signage, or way-finding technology; incremental cost of providing same day service or door-to-door service; purchasing vehicles to support new accessible taxi, ride sharing and/or vanpooling programs; and mobility management.

In 1996, Assembly Bill (AB) 772 was enacted and directed the Commission to have oversight responsibilities for the Section 5310 Program. AB 772 placed three mandates on the Commission regarding the Section 5310 Program: (1) the Commission shall direct Caltrans on how to allocate funds for the Section 5310

Program, (2) the Commission shall establish an appeals process for the Section 5310 Program, and (3) the Commission shall hold at least one public hearing prior to approving its program of projects.

In January of 1997, the Commission approved procedures for the Section 5310 Program, criteria used to score the projects, and a State Review Committee consisting of advocates and representatives from the State Departments of Rehabilitation, Developmental Services and Transportation, with the Commission staff acting in the role of facilitator/coordinator for the State Review Committee.

In accordance with the Commission's adopted procedures, the Metropolitan Planning Organization (MPO) or Regional Transportation Planning Agencies (RTPAs) or its designated Regional Evaluation Committee scores projects within its jurisdiction utilizing the Commission's adopted project scoring criteria and forwards a scored project list to Caltrans. The RTPAs must notify its applicants of their project scores and provide information about the appeals process. The State Review Committee re-scores the projects to verify the scores given at the regional level. In instances where there is a sizable difference between regional and State Review Committee project scores, Caltrans contacts the regions and the differences are thoroughly discussed and resolved.

The Small Urban and Rural Area statewide prioritized list of projects was created at 100 percent of available funds in score order for the Traditional and Expanded components of the Section 5310 Program. In the event that projects programmed are unable to proceed or there are savings, the next project below the 100 percent funding level will be selected for funding. This ensures the use of all federal funds available for the Section 5310 Program.

2019 Section 5310 Program Grant Cycle

The available funding for the 2019 Section 5310 Program is \$14,248,195, including the local match. Successful applicants are able to use Federal Transit Toll Credits as the local match. Eligible Small Urban and Rural agencies submitted 77 applications for 171 projects requesting approximately \$22.3 million in Section 5310 Program funds. The applications were first scored by MPOs/RTPAs. Caltrans reviewed the MPOs/RTPA scores and used the criteria adopted by the Commission to develop a draft statewide priority list and notified the successful and unsuccessful project applicants.

On January 29, 2020, Commission staff were notified that 11 projects were missing from the Small Urban and Rural Area Project list. Upon investigation, Caltrans staff notified the Commission that the projects were miscategorized in the Large Urbanized Area list, which is a section of the program that the Commission does not oversee because the funds are apportioned directly to the Large Urbanized Area. Once discovered, Caltrans moved the 11 projects from the Large Urbanized Area Project list to the Small Urbanized and Rural Area Project list, made efforts to mitigate the impact

of the shift in projects, and contacted the impacted agencies notifying them of the changes.

On February 4, 2020, Caltrans and Commission staff held the required appeals hearing for the Section 5310 program. Four appeals were submitted to this hearing by local agencies representing projects categorized in the Large Urban Area Project list. Caltrans staff concluded that the appealing agencies did not demonstrate that the Commission's adopted program criteria was incorrectly applied in the application review and scoring process. Therefore, Caltrans denied the appeals.

ADOPTION OF THE 2019 SMALL URBAN AND RURAL AREA FEDERAL TRANSIT ADMINISTRATION SECTION 5310 ENHANCED MOBILITY OF SENIORS AND INDIVIDUALS WITH DISABILITIES PROGRAM

- 1.1 WHEREAS, Federal law (Title 49 U.S.C. Section 5310) provides for capital, operating assistance and mobility management grants for the purpose of assisting private non-profit corporations and under certain circumstances, public agencies in providing transportation services to meet the needs of elderly persons and persons with disabilities for whom public mass transportation services are otherwise unavailable, insufficient, or inappropriate, and
- 1.2 **WHEREAS**, State law, Assembly Bill 772 (Chapter 669, Statutes of 1996), placed the following three mandates on the California Transportation Commission (Commission) regarding the Program: a) The Commission shall direct the California Department of Transportation (Caltrans) on how to allocate funds for the Program; b) The Commission shall establish an appeals process for the Program; c) The Commission shall hold at least one public hearing prior to approving its Program of Projects, and
- 1.3 WHEREAS, the Commission worked with a State Review Committee, a 15-member advisory committee made up of individuals from the Regional Transportation Agencies, state and local social service agencies, the California Association for Coordinated Transportation, Caltrans and Commission staff, to develop a process that provides for a statewide ranked list of Small Urban and Rural Area projects to be adopted by the Commission and funded by Caltrans, and
- 1.4 **WHEREAS,** the available funding totals \$14,248,195. This amount is distributed as follows: Traditional (55 percent) and Expanded Projects (45 percent), and
- 1.5 **WHEREAS,** 103 projects for a total of \$8,264,444 for the Traditional program and 25 projects for a total of \$5,983,751 for the Expanded program were selected for funding, and
- 1.6 **WHEREAS**, if projects are not delivered from the funded list or savings are generated, projects below the line will be selected for funding, and
- 1.7 **WHEREAS,** Caltrans and Commission staff held the required appeals hearing on February 4, 2020, and
- 1.8 **WHEREAS,** the appeals hearing did not result in changes to the Small Urban and Rural Area Statewide Prioritized List, and
- 1.9 **WHEREAS**, the Commission held the required public hearing prior to adoption.
- 2.1 **NOW, THEREFORE, BE IT RESOLVED,** that the Commission hereby adopts the attached list of projects, as the 2019 Small Urban and Rural Area Federal Transit Administration Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program, and
- 2.2 **BE IT FURTHER RESOLVED,** that in adopting the attached list, the Commission hereby directs Caltrans to allocate funds for projects on that list down to the level of actual available funding, pursuant to California Government Code Section 14055.2(b).
