# Subject: STATE AND FEDERAL LEGISLATION

#### **ISSUE:**

- 1) Should the California Transportation Commission (Commission) accept the staff report and provide comments on the legislation identified and monitored by staff as presented in Attachment A?
- 2) Should the Commission ratify the letters of support for bills which implement legislative recommendations from the 2015 Annual Report?
- 3) Should the Commission adopt the staff-recommended positions on the bills discussed in this book item?

### **RECOMMENDATION:**

Staff recommends that the Commission:

- 1) Accept the staff report and provide direction to staff on legislation of interest in Attachment A;
- 2) Ratify the letters of support for bills implementing Commission recommendations; and
- 3) Confirm the staff-recommended positions for the discussed bills.

#### **BACKGROUND:**

The Legislative deadline for introducing bills in this second year of the two-year session was February 19<sup>th</sup>, which means that nearly every bill to be considered this session has been introduced. (There are unique situations in which the legislative rules allow for bills to be introduced after the deadline, but it is rare.) For the 2015-16 session, the Assembly introduced 2,904 bills and the Senate introduced 1,474 bills. Notwithstanding any future gut-and-amends, the existing bills affecting the state's transportation system and/or the Commission are identified in Attachment A. For convenience, these bills have been divided into three groups – the primary bills most critical to the Commission, a secondary list of bills that might be of interest to the Commission, and a tertiary list of bills that may be marginally of interest to the Commission.

### **Bills Implementing Commission Recommendations**

Within the primary list in Attachment A are the 15 bills that either fully or at least partially implement 12 of the Commission's 16 legislative recommendations contained in the 2015 Annual Report. Because the Commission recommended that the Legislature enact bills implementing these policies, Commission staff have sent support letters to the authors of the bills listed below (see Attachment B), and recommends the Commission ratify its support for these bills:

**AB 1569 (Steinorth) CEQA Exemptions** – Exempts from CEQA a project, or the issuance of a permit for a project, in the existing right of way that consists of the inspection, maintenance, repair, rehabilitation, or removal of, or the addition of an auxiliary lane or bikeway to, existing transportation infrastructure and that meets certain requirements. Status: Referred to Assembly Natural Resources and Transportation Committees Note: Similar to language included in the Governor's funding proposal

**AB 1833 (Linder) Advance Mitigation/NEPA Delegation** – Creates the Advanced Mitigation Program to implement environmental mitigation measures in advance of future transportation projects. In addition, this bill deletes the sunset date of existing law assigning to the state legal responsibility for the (National Environmental Policy Act (NEPA) environmental review process.

Status: Referred to Assembly Transportation and Natural Resources Committees Note: Similar to language included in the Governor's funding proposal

**AB 1987 (Rodriguez) Tribal Contracting** – Authorizes Caltrans to enter into contracts with the tribal government of a federally-recognized Indian tribe in order to carry out its duties, including disbursement of state and federal transportation funds administered by Caltrans that are designated for expenditure on eligible projects under the jurisdiction of the Tribe.

Status: Referred to Assembly Transportation Committee

**AB 2034 (Salas) NEPA Delegation** – Deletes the sunset date of existing law assigning to the state legal responsibility for the (National Environmental Policy Act (NEPA) environmental review process.

Status: Referred to Assembly Transportation Committee

Note: Similar to language included in the Governor's funding proposal

**AB 2126 (Mullin) State CM/GC Authority** – Authorizes Caltrans to use the Construction Manager/General Contractor (CM/GC) method on twice as many projects as is currently authorized, from six to twelve.

*Status: Introduced – not yet referred to committee* 

Note: Similar to language included in the Governor's funding proposal

**AB 2289 (Frazier) Putting the "O" in SHOPP** – Clarifies existing law to permit Caltrans to use State Highway Operation and Protection Program (SHOPP) funds for operational improvements on the state highway system.

Status: Referred to Assembly Transportation Committee

**AB 2374 (Chiu) Regional CM/GC Authority** – Expands regional transportation agencies' existing off-system CM/GC project delivery authority by also authorizing them to use it on ramps that are not on the state highway system. In addition, removes the requirement that the project be developed in accordance with an expenditure plan approved by voters. *Status: Referred to Assembly Transportation Committee* 

**AB 2452 (Quirk) Improving CEQA** - Prohibits a court from staying or enjoining transportation projects based solely on greenhouse gas emissions as long as the project is included in an approved Sustainable Communities Strategy that has been through a programmatic environmental review.

Status: Referred to Assembly Natural Resources and Judiciary Committees

**AB 2742 (Nazarian) P3 Authority** – Extends Caltrans' and regional transportation agencies' authority to enter into public/private partnership (P3) agreements from the existing deadline of January 1, 2017, to 2030.

Status: Referred to Assembly Transportation Committee

Note: Similar to language included in the Governor's funding proposal

**SB 901 (Bates) Advance Mitigation** – Creates the Advanced Mitigation Program to implement environmental mitigation measures in advance of future transportation projects.

Status: Referred to Senate Transportation and Housing Committee and Committee on Environmental Quality

Note: Similar to language included in the Governor's funding proposal

**SB 902 (Cannella) NEPA Delegation** – Deletes the sunset date of existing law assigning to the state legal responsibility for the (National Environmental Policy Act (NEPA) environmental review process.

Status: Referred to Senate Transportation and Housing Committee Note: Similar to language included in the Governor's funding proposal

**SB 903 (Nguyen) Transportation Loan Repayment** – Requires the General Fund to repay all outstanding transportation-related loans by June 30, 2016.

Status: Referred to Senate Transportation and Housing Committee

Note: Similar to language included in the Governor's funding proposal

In addition, the following two bills are vehicles which we understand the authors intend to amend to implement additional Commission recommendations. When the bills are amended, Commission staff will send letters of support to these authors as well.

**AB 2620 (Dababneh) Sunsetting Proposition 116** – Spot language that will be amended to sunset Prop 116 and make the unspent funds available for other rail purposes.

**AB 2708 (Daly) Pre-certifying A&E Contractors** – Spot language that will be amended to allow Caltrans to pre-certify Architectural and Engineering (A&E) contractors.

Finally, the Assembly Member's funding bill (below) implements many of the Commission's recommendations. The Commission approved a "support in concept" position for this bill at its January meeting.

**AB 1591 (Frazier, D) Transportation Funding** – Increases transportation funding to support the Road Maintenance and Rehabilitation Program through a motor vehicle fuel tax increase, a new vehicle registration fee for zero-emission vehicles, and other fees. Includes a diesel fuel tax increase to fund the Trade Corridors Improvement Fund.

Status: Referred to Assembly Transportation Committee and Committee on Revenue and Taxation

Note: Similar to Senator Beall's SB 16 and SB1x 1

# Bills on Which the Commission May Wish to Take a Position

Beyond the bills implementing the Commission's recommendations, a number of other bills have been introduced that have particular bearing on either the state transportation program or the Commission itself. These bills are grouped by subject below, and include staff's recommended positions with each.

### Freight Funding

**AB 1780 (Medina) Cap and Trade for Freight** – Provides for a continuous appropriation of 25 percent of the annual proceeds of the Greenhouse Gas Reduction Fund to the Commission for a new program called the Sustainable Trade Corridors Program, similar to the Trade Corridor Improvement Fund (TCIF) program.

Status: Referred to Assembly Transportation Committee

Staff Recommendation: Support – The state transportation system desperately needs help to support the tremendous amount of freight traversing the state. The TCIF program was very successful in addressing some of this need, but more funds are necessary to continue the progress. Freight mobility projects that reduce emissions are an appropriate use of cap and trade funds, and therefore staff recommends the Commission consider supporting this proposal.

**AB 2170 (Frazier) FAST Act Freight Funding** – Requires revenues apportioned by formula to the state from the National Highway Freight Program established by the federal FAST Act to be deposited into the Trade Corridors Improvement Fund.

Status: Referred to Assembly Transportation Committee

Staff Recommendation: Support – The state transportation system desperately needs help to support the tremendous amount of freight traversing the state. The TCIF program was very successful in addressing some of this need, but more funds are necessary to continue the progress. This bill would assure that these federal funds were used on freight mobility projects that best address the state's need, and therefore staff recommends the Commission consider supporting this proposal.

#### Oakland Harbor Intermodal Terminal

**SB 1278 (Hancock) Environmental Review** – Requires every public agency with discretionary approval of any portion of a project relating to the shipment of coal through the Port of Oakland to prepare an environmental impact report.

Status: Referred to Senate Transportation and Housing Committee and Committee on Environmental Quality

Staff Recommendation: Oppose unless amended — Environmental impact reports are required to be prepared for projects by lead agencies as defined in CEQA. The Commission is responsible for and only funds projects that have complied with the environmental requirements set forth in CEQA. The Commission does not prepare, or have the expertise to prepare, environmental documents. In addition, the proposed legislation would result in multiple lead agencies for affected projects creating confusion and conflict with CEQA requirements. This bill, as written, would require the Commission to prepare an environmental document which is not the responsibility of the Commission, and therefore the Commission should consider opposing this proposal unless it is amended to exclude the Commission from its requirements.

# **Transportation Loan Repayment**

On March 1st, the Governor signed into law AB 133 (Chapter 2, Statutes of 2016), amending the current 2015-16 fiscal year Budget Act to include, among other things, the repayment of a number of transportation-related loans from the General Fund. Under AB 133, the Director of Finance will transfer a total of \$173 million to the Traffic Congestion Relief Fund no later than January 1, 2017. This appropriation is a portion of the \$879 million in outstanding loans, leaving \$706 million remaining to be repaid. The bill further allocates the funds as follows:

- \$148 million for specified local Traffic Congestion Relief Program (TCRP) projects
- \$11 million for trade corridor improvements
- \$9 million for the Transit and Intercity Rail Capital Program (TIRCP)
- \$5 million for the SHOPP

Finally, the bill states that this repayment is made pursuant to subdivision (c) of Article XVI of the California Constitution and applied to debt payments as required for the 2016-17 fiscal year. This section of the Constitution refers to the Budget Stabilization Account ("Rainy Day Fund") created by Proposition 2 in November 2014. Part of this section's requirements is for the Legislature to appropriate from the Account a certain amount to pay outstanding General Fund obligations, such as these transportation-related loans.

It appears the TCRP funds are meant to fully cover all Tier 2 Projects in the program, which are all the projects that were programmed within 24 months of the creation of the TCRP in 2000, as is statutorily required. TCRP funds are continuously appropriated and therefore, as soon as funds are available the Commission should be able to allocate the funds to the appropriate entities. In addition, the funds for the SHOPP will be transferred to the State Highway Account and will simply increase the amount of funding available for the program by a like amount, not requiring any action by the Legislature or the Commission.

The TIRCP funding is built into the Governor's 2016-17 budget bill, and therefore will be available next fiscal year, if not amended. As for funding trade corridor improvements, it appears that further statutory action will need to be taken in order to direct the funds to the appropriate program. If the Governor's transportation funding budget trailer bill is passed and becomes law, it creates a new Trade Corridor Enhancement Account to be administered similar to the TCIF program and the funds could presumably flow that way. If the bill is not passed, then the Legislature will need to introduce legislation in order for those funds to be spent.

### **Introduced by Senator Hancock**

February 19, 2016

An act to add Section 21080.50 to the Public Resources Code, relating to environmental quality.

### LEGISLATIVE COUNSEL'S DIGEST

SB 1278, as introduced, Hancock. California Environmental Quality Act: Port of Oakland: coal shipment.

The California Environmental Quality Act (CEQA) requires a lead agency, as defined, to prepare, or cause to be prepared, and certify the completion of, an environmental impact report (EIR) on a project that it proposes to carry out or approve that may have a significant effect on the environment or to adopt a negative declaration if it finds that the project will not have that effect. CEQA also requires a lead agency to prepare a mitigated negative declaration for a project that may have a significant effect on the environment if revisions in the project would avoid or mitigate that effect and there is no substantial evidence that the project, as revised, would have a significant effect on the environment.

This bill would require every public agency with discretionary approval of any portion of a project relating to the shipment of coal through the Port of Oakland to prepare or cause to prepare an EIR.

Because a public agency, which includes a local agency, would be required to prepare or cause to prepare an EIR, this bill would impose a state-mandated local program.

This bill would make legislative findings and declarations as to the necessity of a special statute for City of Oakland.

SB 1278 -2-

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The people of the State of California do enact as follows:

- 1 SECTION 1. Section 21080.50 is added to the Public Resources 2 Code, to read:
- 21080.50. Notwithstanding other provisions of this division, every public agency with discretionary approval of any portion of a project relating to the shipment of coal through the Port of Oakland shall prepare or cause to prepare an environmental impact report pursuant to this division.
- SEC. 2. The Legislature finds and declares that a special law is necessary and that a general law cannot be made applicable within the meaning of Section 16 of Article IV of the California Constitution because of the unique nature of coal shipment through the Port of Oakland.
- SEC. 3. No reimbursement is required by this act pursuant to Section 6 of Article XIIIB of the California Constitution because a local agency or school district has the authority to levy service charges, fees, or assessments sufficient to pay for the program or level of service mandated by this act, within the meaning of Section
- level of service mandated by this act, wit17556 of the Government Code.

### **Introduced by Assembly Member Medina**

February 3, 2016

An act to amend Section 39719 of the Health and Safety Code, and to add Section 2192.4 to the Streets and Highways Code, relating to greenhouse gases, and making an appropriation therefor.

#### LEGISLATIVE COUNSEL'S DIGEST

AB 1780, as introduced, Medina. Greenhouse Gas Reduction Fund: Sustainable Trade Corridors Program.

The California Global Warming Solutions Act of 2006 designates the State Air Resources Board as the state agency charged with monitoring and regulating sources of emissions of greenhouse gases. The state board is required to adopt a statewide greenhouse gas emissions limit equivalent to the statewide greenhouse gas emissions level in 1990 to be achieved by 2020. The act authorizes the state board to include the use of market-based compliance mechanisms. Existing law requires all moneys, except for fines and penalties, collected by the state board as part of a market-based compliance mechanism to be deposited in the Greenhouse Gas Reduction Fund and to be available upon appropriation. Existing law continuously appropriates 60% of the annual proceeds of the fund for transit, affordable housing, sustainable communities, and high-speed rail purposes.

This bill, beginning in the 2016–17 fiscal year, would continuously appropriate 25% of the annual proceeds of the fund to the California Transportation Commission for the Sustainable Trade Corridors Program, which the bill would establish, thereby making an appropriation.

AB 1780 -2-

1 SECTION 1. Section 39719 of the Health and Safety Code is 2 amended to read:

- 39719. (a) The Legislature shall appropriate the annual proceeds of the fund for the purpose of reducing greenhouse gas emissions in this state in accordance with the requirements of Section 39712.
- (b) To carry out a portion of the requirements of subdivision (a), annual proceeds are continuously appropriated for the following:
- (1) Beginning in the 2015–16 2016–17 fiscal year, and notwithstanding Section 13340 of the Government Code, 35 60 percent of annual proceeds are continuously appropriated, without regard to fiscal years, for transit, affordable housing, and sustainable communities programs as following: follows:
- (A) Ten percent of the annual proceeds of the fund is hereby continuously appropriated to the Transportation Agency for the Transit and Intercity Rail Capital Program created by Part 2 (commencing with Section 75220) of Division 44 of the Public Resources Code.
- (B) Five percent of the annual proceeds of the fund is hereby continuously appropriated to the Low Carbon Transit Operations Program created by Part 3 (commencing with Section 75230) of Division 44 of the Public Resources Code. Funds Moneys shall be allocated by the Controller, according to requirements of the program, and pursuant to the distribution formula in subdivision (b) or (c) of Section 99312 of, and Sections 99313 and 99314 of, the Public Utilities Code.
- (C) Twenty percent of the annual proceeds of the fund is hereby continuously appropriated to the Strategic Growth Council for the Affordable Housing and Sustainable Communities Program created by Part 1 (commencing with Section 75200) of Division 44 of the Public Resources Code. Of the amount appropriated in this subparagraph, no less than 10 percent of the annual proceeds, proceeds shall be expended for affordable housing, consistent with the provisions of that program.

(D) Twenty-five percent of the annual proceeds of the fund shall be transferred to the Trade Corridors Improvement Fund, continued in existence pursuant to Section 2192 of the Streets and Highways Code, and is hereby continuously appropriated to the California Transportation Commission for the Sustainable Trade Corridors Program created by Section 2192.4 of the Streets and Highways Code.

- (2) Beginning in the 2015–16 fiscal year, notwithstanding Section 13340 of the Government Code, 25 percent of the annual proceeds of the fund is hereby continuously appropriated to the High-Speed Rail Authority for the following components of the initial operating segment and Phase I Blended System as described in the 2012 business plan adopted pursuant to Section 185033 of the Public Utilities Code:
  - (A) Acquisition and construction costs of the project.
  - (B) Environmental review and design costs of the project.
  - (C) Other capital costs of the project.

- (D) Repayment of any loans made to the authority to fund the project.
- (c) In determining the amount of annual proceeds of the fund for purposes of the calculation in subdivision (b), the funds subject to Section 39719.1 shall not be included.
- SEC. 2. Section 2192.4 is added to the Streets and Highways Code, to read:
- 2192.4. (a) The Sustainable Trade Corridors Program is hereby established and shall be administered by the commission.
- (b) (1) Moneys appropriated to the commission for the program from the Greenhouse Gas Reduction Fund, pursuant to Section 39719 of the Health and Safety Code, shall be allocated by the commission consistent with the requirements of this chapter.
- (2) At least 10 percent of the moneys available for the program shall be allocated for research and development projects that promote sustainable trade corridors, consistent with the requirements of Section 2192.2.
- (c) (1) Applications for grants under the program shall be submitted to the commission for evaluation in accordance with procedures and program guidelines approved by the commission.
- (2) The application shall define the project purpose, intended scope, proposed cost, intended funding sources, and schedule for project completion.

## **Introduced by Assembly Member Frazier**

February 18, 2016

An act to amend Section 2192 of the Streets and Highways Code, relating to transportation.

### LEGISLATIVE COUNSEL'S DIGEST

AB 2170, as introduced, Frazier. Trade Corridors Improvement Fund: federal funds.

The Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006 (Proposition 1B) created the Trade Corridors Improvement Fund and provided for allocation by the California Transportation Commission of \$2 billion in bond funds for infrastructure improvements on highway and rail corridors that have a high volume of freight movement, and specified categories of projects eligible to receive these funds. Existing law continues the Trade Corridors Improvement Fund in existence in order to receive revenues from sources other than the bond act for these purposes.

This bill would require revenues apportioned to the state from the National Highway Freight Program established by the federal Fixing America's Surface Transportation Act to be deposited in the Trade Corridors Improvement Fund.

The people of the State of California do enact as follows:

SECTION 1. Section 2192 of the Streets and Highways Code is amended to read:

- 2192. (a) The Trade Corridors Improvement Fund, created pursuant to subdivision (c) of Section 8879.23 of the Government Code, is hereby continued in existence to receive revenues from sources other than the Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006. 2006, including revenues apportioned to the state under Section 167 of the Title 23 of the United States Code from the National Highway Freight Program, pursuant to the federal Fixing America's Surface Transportation Act ("FAST Act"; Public Law 114-94). This chapter shall govern expenditure of those other revenues.
- (b) The moneys in the fund from those other sources shall be available upon appropriation for allocation by the California Transportation Commission for infrastructure improvements in this state on federally designated Trade Corridors of National and Regional Significance, on the Primary Freight Network, and along other corridors that have a high volume of freight movement, as determined by the commission. In determining the projects eligible for funding, the commission shall consult the Transportation Agency's state freight plan as described in Section 13978.8 of the Government Code, the State Air Resources Board's Sustainable Freight Strategy adopted by Resolution 14-2, and the trade infrastructure and goods movement plan submitted to the commission by the Secretary of Transportation and the Secretary for Environmental Protection. The commission shall also consult trade infrastructure and goods movement plans adopted by regional transportation planning agencies, adopted regional transportation plans required by state and federal law, and the statewide port master plan prepared by the California Marine and Intermodal Transportation System Advisory Council (Cal-MITSAC) pursuant to Section 1730 of the Harbors and Navigation Code, when determining eligible projects for funding. Eligible projects for these funds include, but are not limited to, all of the following:
- (1) Highway capacity improvements and operational improvements to more efficiently accommodate the movement of freight, particularly for ingress and egress to and from the state's land ports of entry and seaports, including navigable inland

waterways used to transport freight between seaports, land ports of entry, and airports, and to relieve traffic congestion along major trade or goods movement corridors.

- (2) Freight rail system improvements to enhance the ability to move goods from seaports, land ports of entry, and airports to warehousing and distribution centers throughout California, including projects that separate rail lines from highway or local road traffic, improve freight rail mobility through mountainous regions, relocate rail switching yards, and other projects that improve the efficiency and capacity of the rail freight system.
  - (3) Projects to enhance the capacity and efficiency of ports.
- (4) Truck corridor improvements, including dedicated truck facilities or truck toll facilities.
- (5) Border access improvements that enhance goods movement between California and Mexico and that maximize the state's ability to access coordinated border infrastructure funds made available to the state by federal law.
- (6) Surface transportation and connector road improvements to effectively facilitate the movement of goods, particularly for ingress and egress to and from the state's land ports of entry, airports, and seaports, to relieve traffic congestion along major trade or goods movement corridors.
- (c) (1) The commission shall allocate funds for trade infrastructure improvements from the fund consistent with Section 8879.52 of the Government Code and the Trade Corridors Improvement Fund (TCIF) Guidelines adopted by the commission on November 27, 2007, or as amended by the commission, and in a manner that (A) addresses the state's most urgent needs, (B) balances the demands of various land ports of entry, seaports, and airports, (C) provides reasonable geographic balance between the state's regions, and (D) places emphasis on projects that improve trade corridor mobility while reducing emissions of diesel particulate and other pollutant emissions.
- (2) In addition, the commission shall also consider the following factors when allocating these funds:
- (A) "Velocity," which means the speed by which large cargo would travel from the land port of entry or seaport through the distribution system.

(B) "Throughput," which means the volume of cargo that would move from the land port of entry or seaport through the distribution 3 system.

- (C) "Reliability," which means a reasonably consistent and predictable amount of time for cargo to travel from one point to another on any given day or at any given time in California.
- (D) "Congestion reduction," which means the reduction in recurrent daily hours of delay to be achieved. 7
