Ms. Bransen serves as the California Transportation Commission's (Commission) Executive Director, reporting to the thirteen-member Commission. She has a major role in affecting the outcome of all policies and actions adopted by the Commission including the programming and allocation of several billion dollars annually for the construction of highway, passenger rail, transit and active transportation improvements throughout California. Ben Metcalf, Director, California Department of Housing and Community Development

On February 29, 2016, Governor Edmund G. Brown, Jr. appointed Mr. Metcalf as Director of the California Department of Housing and Community Development (HCD). HCD provides leadership, policies, and programs to preserve and expand safe and affordable housing opportunities and promote strong communities for all Californians. This includes ongoing direct oversight of approximately one thousand multifamily affordable properties, more than 3,600 mobilehome parks, and review of housing element plans for 539 California jurisdictions. In addition, HCD is responsible for revising and updating the CalGreen building standards and awarding approximately half a billion dollars per year to support new affordable housing.

In addition, an in-depth Statewide Housing Assessment titled "California's Housing Future: Challenges and Opportunities" was also released under Mr. Metcalf's leadership. This draft report was the first of its kind in more than 15 years and revealed California's far-reaching housing challenges and offered a full suite of possible policy responses.

Prior to HCD, Mr. Metcalf worked at the U.S. Department of Housing and Urban Development (HUD) in Washington, D.C., where he served, most recently, as an appointee of President Barack Obama in the role of Deputy Assistant Secretary of the Office of Multifamily Housing Programs. Prior to HUD, Mr. Metcalf worked with

BRIDGE Housing Corporation, a California-based real estate development company that focuses on affordable housing and public/private partnerships.

Mr. Metcalf was a Center for Redevelopment Excellence Fellow at the University of Pennsylvania, and in 2006 was named "Young Leader of the Year" by Affordable Housing Finance. Mr. Metcalf earned his Bachelor of Arts in history from Amherst College and his Master in public policy and urban planning from Harvard University, Kennedy School of Government. Mr. Metcalf serves on the board of directors of the California Housing Partnership Corporation, the California Housing Finance Agency, and the California Housing Consortium.

Joe Myers, Chair, Native American Advisory Committee

JOSEPH A. MYERS, a Pomo Indian of northern California, is the Executive Director of the National Indian Justice Center (NIJC), a non-profit corporation in Santa Rosa, California. He founded the NIJC in 1983, as an independent resource for tribal governments and their courts. NIJC creates and conducts legal education, research, and technical assistance programs aimed at improving the administration of justice in Indian country. From 1976 to 1983 Mr. Myers served as associate director of the American Indian Lawyer Training Program, creating and managing its tribal court advocate training project. He is a graduate of the University of California, Berkeley (UCB), School of Law at Boalt Hall. Mr. Myers has contributed significantly to the improvement of education, justice and the quality of life in Indian country. For the past 20 years he has lectured in Native American Studies at UCB. In 1993, Mr. Myers received national recognition from Attorney General Janet Reno for his work on behalf of victims of crime in Indian country. On December 6, 2002, the California Wellness Foundation awarded him the California Peace Prize for his work in violence prevention on Indian reservations. Additionally, Mr. Myers is a founding board member of the California Indian Museum and Cultural Center. Since 2002 he has served as Chairperson of CALTRANS Native American Advisory Committee. UCB recently honored Mr. Myers by naming a research center in his honor. The Joseph A. Myers Center is housed at UC Berkeley's Institute for the Study of Societal Issues (ISSI), the center's name is intended to recognize his extensive service to Indian country.
