Subject: Approval of Project for Future Consideration of Funding – Negative Declaration for the Hartley Street Pedestrian Improvement Project (Resolution E-19-92)

<u>lssue:</u>

Should the California Transportation Commission (Commission), as a Responsible Agency, accept the Negative Declaration for the Hartley Street Pedestrian Improvement Project (Project) in Lake County and approve the Project for future consideration of funding?

Recommendation:

Commission Staff recommends the Commission accept the Negative Declaration and approve the Project for future consideration of funding.

Background:

The City of Lakeport (City) is the California Environmental Quality Act lead agency for the Project. The Project will widen roadway and install pavement, including concrete sidewalks, curbs, gutters, and Americans with Disabilities Act compliant ramps along an approximate 2,800-foot portion of Hartley Street. The Project is located within the northern portion of the City of Lakeport, one-half mile west of Clear Lake and one-half mile east of Highway 29 in Lake County.

On August 28, 2019, the City Planning Commission adopted a Negative Declaration for the Project and found that the Project will not have a significant effect on the environment.

On September 9, 2019, the City confirmed that the preferred alternative set forth in the final environmental document is consistent with the Project scope of work programmed by the Commission.

The Project is estimated to cost \$1,852,000 and is fully funded through construction with Active Transportation Program Funds.

Construction is estimated to begin in Fiscal Year 2020-21.


