Subject: Approval of Project for Future Consideration of Funding – Final Environmental Impact Report for the Monterey Bay Sanctuary Scenic Trail Network Master Plan, including Addendums 1 and 2, for the Watsonville Rail Trail Lee Road Project (Resolution E-19-91)

Issue:

Should the California Transportation Commission (Commission), as a Responsible Agency, accept the Final Environmental Impact Report for the Monterey Bay Sanctuary Scenic Trail Network Master Plan, including Addendums 1 and 2, for the Watsonville Rail Trail Lee Road (Project) in Santa Cruz County, and approve the Project for future consideration of funding?

Recommendation:

Commission Staff recommends the Commission accept the Final Environmental Impact Report, including Addendums 1 and 2, and approve the Project for future consideration of funding.

Background:

The Santa Cruz County Regional Transportation Commission (SCCRTC) and the City of Watsonville (City) are the lead agencies for this Project. The Monterey Bay Sanctuary Scenic Trail Network Master Plan proposes a trail alignment for the length of Santa Cruz County, connecting spurs and establishing trail standards for bicycle and pedestrian usage. The trail network travels through a variety of landscapes and covers nearly a 50-mile length. The Master Plan identifies 20 trail segments and the City of Watsonville has identified the Watsonville Rail Trail Lee Road Project as Segment 18. The Project will construct the new trail adjacent to the railroad tracks in Watsonville. The Project is located next to the tracks from Lee Road to Walker Street in Santa Cruz County.

On November 7, 2013, the SCCRTC adopted the Final Environmental Impact Report and determined that environmental impacts would not have a significant effect on the environment after mitigation as outlined in the Mitigation Monitoring and Reporting Program.

Impacts that require mitigation measures to be reduced to less than significant levels relate to agriculture, biological and cultural resources, geology, hazardous materials, water quality, noise, and traffic. Mitigation measures include, but are not limited to: consult with the Agricultural Commissioner's Office on chemical spraying reduction strategies, prepare surveys for protection of the California Red-Legged Frog, minimize disturbance to Monarch Butterfly roosting areas, complete pre-archaeological surveys, prepare a Geotechnical Study to identify potential areas vulnerable to liquefaction, develop an Arsenic Management Plan for protection of water resources, utilize mufflers to manage noise from internal combustion engines, and deploy proper trail signage and warnings.

Since adoption of the Final Environmental Impact Report, the City has issued two modifications to the Final Environmental Impact Report.

On October 13, 2015, the SCCRTC approved Addendum 1 to the Final Environmental Impact Report to formally identify trail Segment 18, and the relocation of four-foot by six-foot railroad buildings.

On July 9, 2019, the Watsonville City Council approved Addendum 2 to the Final Environmental Impact Report to finalize trail design specifications and shift the alignment to avoid the four-foot by six-foot railroad buildings.

On September 9, 2019, the City confirmed that the Final Environmental Impact Report, including the two Addendums, remain valid and that there are no new identified impacts requiring mitigation. The City also confirmed that the preferred alternative set forth in the final environmental document is consistent with the Project scope of work programmed by the Commission.

The Project is estimated to cost \$4,800,000 and is fully funded with Active Transportation Program Funds (\$600,000), and Local Funds (\$4,200,000).

Construction is estimated to begin in Fiscal Year 2019-20.

- 1.11 WHEREAS, on September 9, 2019, the City also confirmed that the preferred alternative set forth in the final environmental document is consistent with the Project scope of work programmed by the Commission; and
- 1.12 WHEREAS, the Commission, as a Responsible Agency, has considered the information contained in the Final Environmental Impact Report, including Addendums 1 and 2.
