# Subject: ALLOCATION FOR THE LOCALLY-ADMINISTERED SENATE BILL 1 LOCAL PARTNERSHIP PROGRAM PROJECT (FORMULAIC) OFF THE STATE HIGHWAY SYSTEM RESOLUTION LPP-A-1920-02

#### ISSUE:

Should the California Transportation Commission (Commission) approve an allocation of \$12,000,000 for the locally-administered Senate Bill 1 (SB 1) Local Partnership Program (LPP) (Formulaic) Voigt Drive Street Improvements project (PPNO 1354), off the State Highway System, in San Diego County?

#### **RECOMMENDATION:**

The California Department of Transportation recommends that the Commission approve an allocation of \$12,000,000 for the locally-administered SB 1 LPP (Formulaic) Voigt Drive Street Improvements project (PPNO 1354), off the State Highway System, in San Diego County.
