ISSUE:

Should the California Transportation Commission (Commission) approve a Senate Bill 1 (SB 1) Trade Corridor Enhancement Program (TCEP) Project Baseline Agreement Amendment to reflect \$18,851,000 in Proposition 1B Trade Corridor Improvement Funds (TCIF) for the Montebello Grade Separation project (PPNO TC0008) in Los Angeles County?

RECOMMENDATION:

The California Department of Transportation (Department) recommends that the Commission approve its request to amend the SB 1 TCEP Project Baseline Agreement and establish it as the basis for project delivery and monitoring.

This amendment request will add \$18,851,000 in Proposition 1B TCIF project cost savings to the Montebello Boulevard Grade Separation project. The Montebello Boulevard Grade Separation project is one of six projects included in the Baseline Agreement for the Southern California Rail project.

BACKGROUND:

The Montebello Boulevard Grade Separation project will separate the roadway and the railroad tracks on Montebello Boulevard in the City of Montebello, along the Alameda Corridor-East Trade Corridor.

The Project Baseline Agreement was approved in October 2018, with \$49,000,000 programmed for construction. Due to industrywide construction cost inflation (steel and concrete costs) experienced by multiple public agencies in Southern California, the

construction phase costs were re-estimated in 2019 at \$126,557,000, an increase of \$50,807,000.

With the support of the Southern California Consensus Group, the San Gabriel Valley Council of Governments proposes to amend the Proposition 1B TCIF Program by including the Montebello Boulevard Grade Separation Project as Project 132 with \$18,851,000 in funding.

The funding for this amendment is made available through savings generated from other projects programmed in the TCIF and is consistent with the TCIF Program Close-Out Policy approved at the May 2019 Commission meeting.

A construction allocation of the programmed SB 1 TCEP and Proposition 1B TCIF is expected to be requested by June 2020.
