#### Subject: REQUEST TO EXTEND THE PERIOD OF PROJECT DEVELOPMENT EXPENDITURES FOR ACTIVE TRANSPORTATION PROJECTS, PER ATP GUIDELINES WAIVER 20-15

## **ISSUE:**

Should the California Transportation Commission (Commission) extend the period of project development expenditure for five projects, programmed in the Active Transportation Program (ATP), for the time period identified in the attachment?

#### **RECOMMENDATION:**

The California Department of Transportation recommends the Commission extend the period of project development expenditure for five projects, programmed in the ATP, for the time period identified in the attachment.

# BACKGROUND:

The Commission allocated \$3,682,000 for five projects as identified on the attachment. The responsible agencies have been unable to complete the phases within the expenditure periods. The attachment describes the details of the projects and the explanation for the delay. The agencies request an extension, and their respective planning agencies concur.

Current ATP Guidelines, adopted by the Commission, stipulate that funds programmed for all components of local grant projects are available for expenditure only until the end of the second fiscal year following the year of allocation. The Commission may approve a waiver to the "timely use of funds" deadline, one-time only, for up to 12 months.

Additional time is needed to coordinate design with UPRR, apply for encroachment permits, and create maintenance agreements which require action from the Oakland City Council. # **DTLA Arts District Pedestrian and Cyclist Safety Project**

The City of Los Angeles (City) is requesting a 12-month time extension to the project development expenditure period for the Plans, Specifications & Estimates (PS&E) phase for the DTLA Arts District Pedestrian and Cyclist Safety Project (DTLA). The City experienced unforeseen delays during the design of the project.

The focus of the project is to implement pedestrian and cyclist improvements within the Arts Districts. During the design process a conflict was discovered with a competing project within the DTLA project limits. The City is required to construct a low flow diversion (LFD) in response to the Los Angeles Regional Water Quality Control Board mandate to reduce dry weather pollutant flows to the adjacent Los Angeles River. The LFD construction requires large excavations through the DTLA project area and would damage all improvements if installed after completion of this project. Therefore, to avoid duplicate work and minimize conflicts the City is requesting a time extension to allow the City to revise the bid package and adjust the construction schedule to coordinate with the LFD project.

Therefore, the City is requesting a 12-month expenditure extension for PS&E from June 30, 2020, to June 30, 2021.

# Cabazon Safe Routes to School Sidewalk Safety Improvements

There are 13 properties requiring Right of Way (RW) and/or a temporary easement; including a parcel owned by the Morongo Band of Mission Indians (Tribe). The coordination and negotiations between the Department, the Tribe and the Bureau of Indian Affairs (BIA) is taking longer than originally anticipated. This has delayed the RW phase of the project. Finalizations of PS&E will occur once property owners agree with the design and compensation. This project has a concurrent time extension request for its RW expenditure on this month's Commission agenda.

Therefore, the County is requesting a seven-month expenditure extension for PS&E from June 30, 2020, to January 31, 2021.
