Subject: RIGHT OF WAY CAPITAL ALLOCATION FOR STIP PROJECTS

RESOLUTION FP-19-94

ISSUE:

Should the California Transportation Commission (Commission) approve an allocation of \$26,400,000 for the Right of Way capital phase for a State Transportation Improvement Program (STIP) project (PPNO 4353) on State Route (SR) 138, in Los Angeles County, programmed in Fiscal Year 2019-20?

RECOMMENDATION:

The California Department of Transportation (Department) recommends that the Commission approve an allocation of \$26,400,000 for the Right of Way capital phase for a STIP project (PPNO 4353), on SR 138, in Los Angeles County, programmed in 2019-20.

BACKGROUND:

Per Resolution G-19-01, projects with Right of Way capital programming of \$10 million or more, and that are programmed with Right of Way capital for 2019-20 or later, must receive Commission approval for project level allocation.

This project is located in the city of Littlerock on SR 138 in the County of Los Angeles. The project proposes to widen the conventional highway from two lanes to four lanes with a median turn lane. The following are utilities that will need relocation: Charter Communication Company (cable), Southern California Edison, Southern California Gas (gas line), Los Angeles County Waterworks District (water line), and American Telephone and Telegraph. There are 42 parcels that require partial acquisition and/or temporary construction easements. Thirtyone of the parcels are residential, while 11 of the parcels are commercial properties. There is no railroad involvement.
