Subject: ALLOCATION FOR LOCALLY-ADMINISTERED SENATE BILL 1 LOCAL PARTNERSHIP PROGRAM (FORMULAIC) PROJECTS OFF THE STATE HIGHWAY SYSTEM RESOLUTION LPP-A-1920-19

ISSUE:

Should the California Transportation Commission (Commission) approve an allocation of \$939,000 for five locally-administered Senate Bill 1 (SB 1) Local Partnership Program (LPP) (Formulaic) projects, off the State Highway System?

RECOMMENDATION:

The California Department of Transportation recommends that the Commission approve an allocation of \$939,000 for five locally-administered SB 1 LPP (Formulaic) projects, off the State Highway System.

BACKGROUND:

The attached vote list describes five locally-administered SB 1 LPP (Formulaic) projects totaling \$939,000. The local agencies are ready to proceed with these projects, and are requesting an allocation at this time.

FINANCIAL RESOLUTION:
