Subject: Approval of Project for Future Consideration of Funding – Mitigated Negative Declaration for the Shoemaker Bridge Replacement Project, Resolution E-20-65

Recommendation:

Staff recommends the California Transportation Commission (Commission), as a Responsible Agency, accept the Mitigated Negative Declaration for the Shoemaker Bridge Replacement Project (Project) in Los Angeles County and approve the Project for future consideration of funding.

<u>lssue:</u>

The City of Long Beach (City) is the California Environmental Quality Act lead agency for the Project. The Project will replace the Shoemaker Bridge and add pedestrian, bicycle, and other street enhancements. The project is located in the southern end of State Route 710 in the City of Long Beach.

For all projects that are anticipated to be funded through a program under the purview of the Commission, full compliance with the California Environmental Quality Act (CEQA) is required. The Commission will not allocate funds to projects for design, right-of-way or construction until the environmental document is complete, and the Commission has approved the environmentally cleared project for future funding consideration.

Background:

On April 21, 2020, the Long Beach City Council adopted a Mitigated Negative Declaration for the Project and found that the Project would not have a significant effect on the environment after mitigation.

Impacts that require mitigation measures to be reduced to less than significant levels relate to biological resources and geology. Mitigation measures include, but are not limited to, conduct a Habitat Mitigation and Monitoring Plan for protection of the Northern Anchovy, adhere to

Section 404 of the Clean Water Act for control of tidal confluence, and prepare a Paleontological Mitigation Plan for monitoring sediments.

On April 28, 2020, the City confirmed that the preferred alternative set forth in the final environmental document is consistent with the Project scope of work programmed by the California Transportation Commission.

The Project is estimated to cost \$30,700,000 and is funded through design with State Transportation Improvement Program Funds (\$14,000,000) and Measure R Funds (\$16,700,000).

Construction is estimated to begin in Fiscal Year 2022-23.


