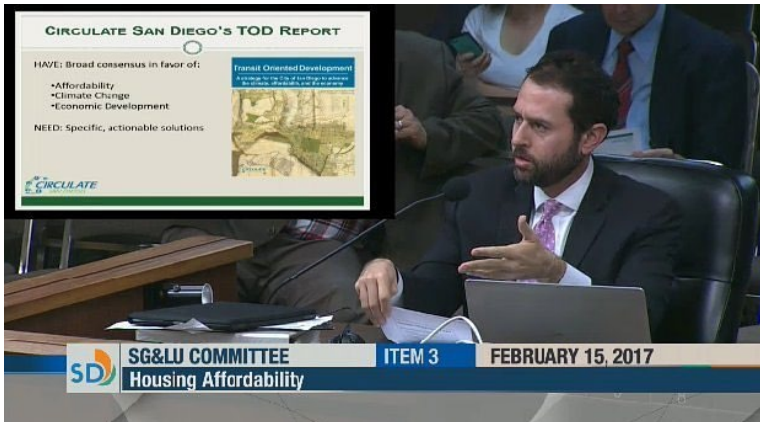

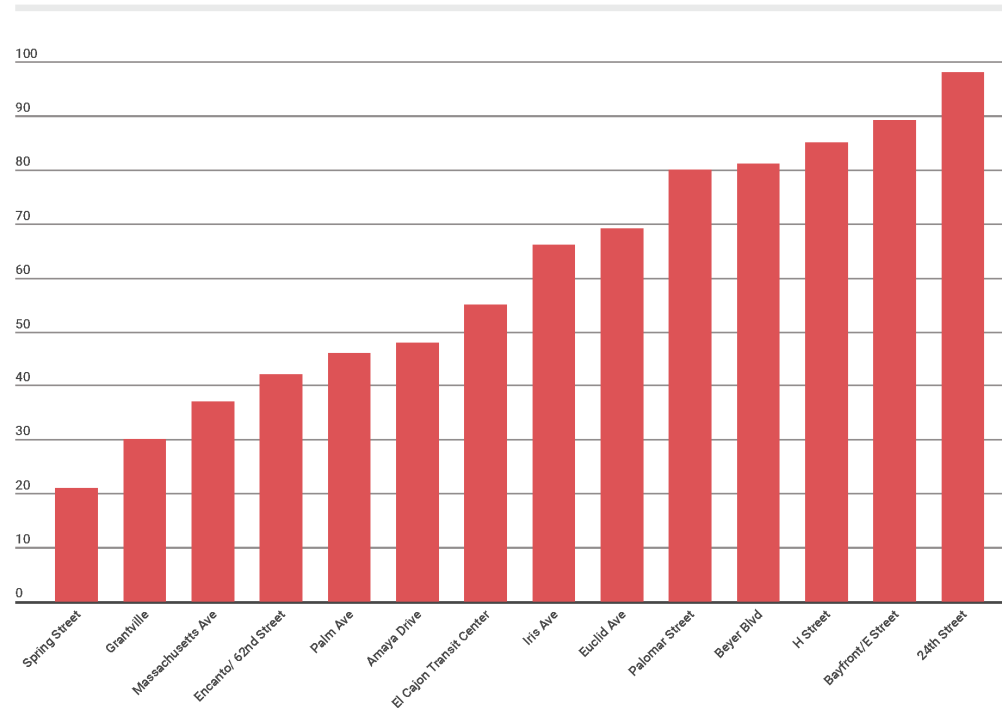
Circulate San Diego's Advocacy Model



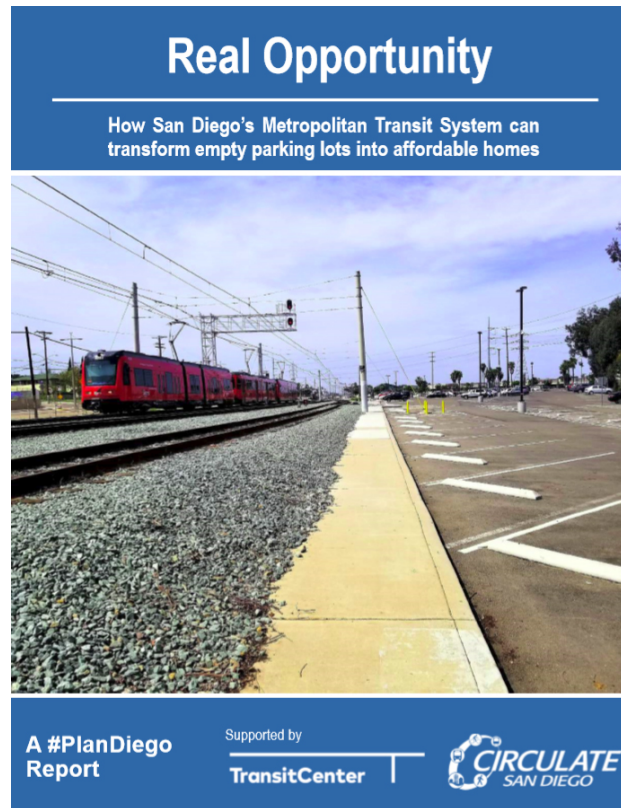
1. Identify a Problem: Wasted transit agency land

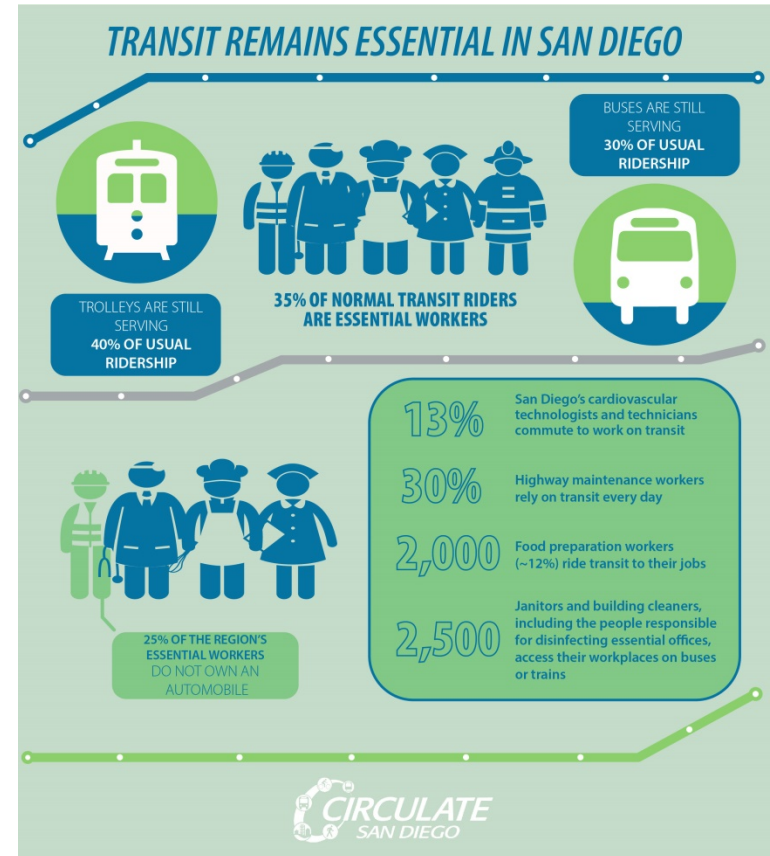

- **CARES Act Funding**
 - *Transportation for America and TransitCenter organized national advocacy effort*
 - *Transit operators advocated separately (Let's team up!)*
- **Maintenance of Service**
 - *Anti-Transit v. Pro-Transit*
- **COVID Protection of Riders/ Operators**
 - *Collaboration between unions and advocates*
 - *Concerns about equitable enforcement*
 - *Rear-door boarding/ touch-less fare payments*

- Essential workers are 35 percent of region's transit riders

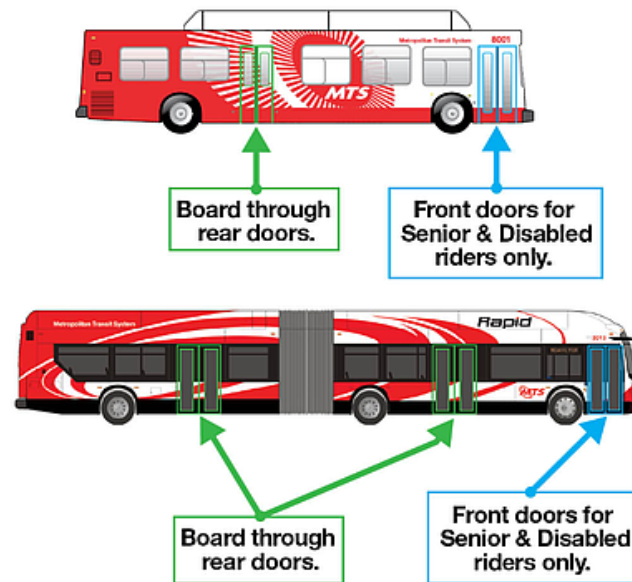

MTS Board Approves Diversion Program for Fare Violators; Reveals Electric Bus Transition Plan

Thursday, June 18, 2020

San Diego - The San Diego Metropolitan Transit System (MTS) Board of Directors approved a fare enforcement pilot program that reduces fines and allows fare violators new options for paying off citations. Additionally, MTS staff unveiled a plan to convert nearly its entire bus fleet to all-electric by 2040.
