### **ISSUE:**

Should the California Transportation Commission (Commission), as a responsible agency, approve the attached Resolutions E-21-01, E-21-02, E-21-03, E-21-04, E-21-05, E-21-06, E-21-07, E-21-08, E-21-09, E-21-10, E-21-11, E-21-12?

### **RECOMMENDATION:**

The California Department of Transportation (Department) recommends that the Commission, as a responsible agency, approve the attached Resolutions E-21-01, E-21-02, E-21-03, E-21-04, E-21-05, E-21-06, E-21-07, E-21-08, E-21-09, E-21-10, E-21-11, E-21-12.

### **BACKGROUND:**

### 01-Men-162, PM 8.2 Resolution E-21-01

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

 State Route (SR) 162 in Mendocino County. Seismically upgrade South Eel River Bridge on SR 162 in Mendocino County. (PPNO 4692)

This project is located on SR 162 near Longvale in Mendocino County. The Department proposes to upgrade the South Eel River Bridge to an earthquake-resistant bridge structure capable of resisting a maximum credible earthquake. This project is currently programmed in the 2020 State Highway Operation Protection Program (SHOPP) for a total of \$13,339,000 which includes Construction (capital and support) and Right of Way (capital and support).

Construction is estimated to begin in Fiscal Year 2021-2022. The scope, as described for the preferred alternative, is consistent with the project scope programmed by the Commission in the 2020 SHOPP.

A copy of the MND has been provided to Commission staff. The project will result in less than significant impacts to the environment after mitigation. The following resource areas may be impacted by the project: biological resources. Avoidance and minimization measures will reduce any potential effects on the environment. These measures include, but are not limited to, designing the bridge to provide habitat for bat Species of Special Concern like the habitat that exists presently. As a result, an MND was completed for this project.

The attached resolution proposes to approve for future consideration of funding the following project for which a Negative Declaration (ND) has been completed:

 State Route (SR) 299 and United States (US) 101 in Humboldt County. Extend the SR 299 entrance ramp onto northbound US 101 to the Giuntoli Lane exit ramp in Humboldt County. (PPNO 2424)

This project is located on US 101 in Arcata in Humboldt County. The Department is proposing to improve merging movements by extending the SR 299 entrance ramp onto northbound U.S. 101 to the Giuntoli Lane exit ramp at the SR 299/US 101 Separation. This project is fully funded and is currently programmed in the 2020 SHOPP for a total of \$8,603,000 which includes Construction (capital and support) and Right of Way (capital and support). Construction is estimated to begin in 2022-23. The scope, as described for the preferred alternative, is consistent with the project scope programmed by the Commission in the 2020 SHOPP.

A copy of the ND has been provided to Commission staff. The project will result in less than significant impacts to the environment. As a result, an ND was completed for this project.

### 03-But-70, PM 46.0/47.0 Resolution E-21-03

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

 State Route (SR) 70 in Butte County. Raise existing roadway profile approximately 5 feet on SR 70 in Butte County. (PPNO 2293)

This project is located on SR 70 on the east bank North Fork Feather River within the Feather River Canyon in eastern Butte County approximately 4.3 miles northeast of the town of Pulga and 25 miles northeast of Oroville. This project proposes to improve a damaged section of roadway on SR 70 by raising the existing roadway profile in the project limits approximately 5 feet, replacing the Bear Creek Bridge, protecting the embankment with Rock Slope Protection, and placing an earth retaining structure against future flood damage. This project is fully funded and is currently programmed in the 2020 SHOPP for a total of \$58,866,000 which includes Construction (capital and support) and Right of Way (capital and support). Construction is estimated to begin in 2022. The scope, as described for the preferred alternative, is consistent with the project scope programmed by the Commission in the 2020 SHOPP.

A copy of the MND has been provided to Commission staff. The project will result in less than significant impacts to the environment after mitigation. The following resource areas may be impacted by the project: wetland and other waters, biological resources, and cultural resources. Avoidance and minimization measures will reduce any potential effects on the environment. These measures include, but are not limited to, the purchase of mitigation bank credits or offsite permittee responsible mitigation for waters and wetlands, rehabilitation of approximately 0.04 acres of creek channel and bank for biological resources, and the production of a short film documenting the evolution of the Feather River Canyon for cultural resources. As a result, an MND was completed for this project.

### 03-Col-20, PM 34.8/36.5 Resolution E-21-04

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

 State Route (SR) 20 in Colusa County. Install standard 8-foot shoulders, provide a 20-foot Clear Recovery Zone, and rehabilitate the drainage system on SR 20 in Colusa County. (PPNO 2951)

This project is located on SR 20 in Colusa County between the cities of Colusa and Yuba City, from Niagara Avenue to west of Steidlmayer Road. The Department proposes to widen shoulders to 8 feet, provide a 20-foot Clear Recovery Zone (CRZ), and rehabilitate the drainage system along the road. This project is fully funded and is currently programmed in the 2020 SHOPP for a total of \$14,620,000 which includes Construction (capital and support) and Right of Way (capital and support). Construction is estimated to begin in 2021-22. The scope, as described for the preferred alternative, is consistent with the project scope programmed by the Commission in the 2020 SHOPP.

A copy of the MND has been provided to Commission staff. The project will result in less than significant impacts to the environment after mitigation. The following resource areas may be impacted by the project: biological resources. Avoidance and minimization measures will reduce any potential effects on the environment. These measures include, but are not limited to, the purchase of mitigation bank credits or "in-lieu-fee" mitigation for the loss of 3.021 acres of jurisdictional wetland and 0.001 acres of jurisdictional waters of the United States. As a result, an MND was completed for this project.

The attached resolution proposes to approve for future consideration of funding the following project for which a Negative Declaration (MND) has been completed:

 Interstate 680 (I-680) in Alameda and Contra Costa Counties. Construct High Occupancy Vehicle/express lanes (HOV/express lanes) on I-680 in Alameda and Contra Costa Counties. (EA 0Q300)

The project is located along approximately nine miles of I-680 in Alameda and Contra Costa Counties near the cities of near Pleasanton, Dublin, and San Ramon, and the community of Sunol. The Department, in cooperation with the Alameda County Transportation Commission (Alameda CTC), proposes to construct High Occupancy Vehicle/express lanes (HOV/express lanes) on northbound and southbound I-680 from State Route 84 (Vallecitos Road) in Alameda County to north of Alcosta Boulevard in Contra Costa County. This project

is not fully funded. The project is estimated to cost \$480 million with \$30 million currently programmed from the Alameda County local tax measures. Additional funding is anticipated to come from additional local tax measure, Senate Bill 1 programs, Regional Measure 1, and the State Transportation Improvement Program (STIP). The project is expected to be constructed in phases with a construction start estimated in 2024-25.

A copy of the MND has been provided to Commission staff. The project will result in less than significant impacts to the environment after mitigation. The following resource areas may be impacted by the project: biological resources. Avoidance and minimization measures will reduce any potential effects on the environment. These measures include, but are not limited to, pre-construction surveys for special-status wildlife species and monitoring during construction. As a result, an MND was completed for this project.

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

 State Route (SR) 1 in San Luis and Santa Barbara Counties. Replace the Santa Maria River Bridge on SR 1 at the border of San Luis Obispo County and Santa Barbara County. (PPNO 2650)

This project is located on SR 1 at the border of San Luis Obispo County and Santa Barbara County, just north of the City of Guadalupe. The project proposes to replace the Santa Maria River Bridge, realign roadways, replant vegetation, and relocate utilities. This project is fully funded and is currently programmed in the 2020 SHOPP for a total of \$50,550,000 which includes Construction (capital and support) and Right of Way (capital and support). Construction is estimated to begin in 2023. The scope, as described for the preferred alternative, is consistent with the project scope programmed by the Commission in the 2020 SHOPP.

A copy of the MND has been provided to Commission staff. The project will result in less than significant impacts to the environment after mitigation. The following resource areas may be impacted by the project: biological resources. Avoidance and minimization measures will reduce any potential effects on the environment. These measures include, but are not limited to, restoring red-legged frog habitat disturbed by construction. As a result, an MND was completed for this project.

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

 State Route (SR) 79 in Riverside County. Construct eight-foot paved shoulders, install rumble strips, and widen Temecula Creek Bridge on SR 79 in Riverside County. (PPNO 3006G)

This project is located on SR 79 in Riverside County near Temecula. The Department proposes to construct eight-foot paved shoulders, install rumble strips, and widen the Temecula Creek Bridge within the project area to reduce the number and severity of collisions and improve motorist safety. This project is fully funded and is currently programmed in the 2020 SHOPP for a total of \$78,921,000 which includes Construction (capital and support) and Right of Way (capital and support). Construction is estimated to begin in 2022-23. The scope, as described for the preferred alternative, is consistent with the project scope programmed by the Commission in the 2020 SHOPP.

A copy of the MND has been provided to Commission staff. The project will result in less than significant impacts to the environment after mitigation. The following resource areas may be impacted by the project: cultural and biological resources. Avoidance and minimization measures will reduce any potential effects on the environment. These measures include, but are not limited to, shallow grading to permit cultural monitoring during construction and preconstruction surveys to locate special-status plant species prior to construction. As a result, an MND was completed for this project.

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

Interstate 10 (I-10) in San Bernardino County and Riverside County. Extend the
eastbound truck climbing lane on I-10 from its current terminus, at the eastbound off-ramp
to the Live Oak interchange, to eastbound of the County Line Road off-ramp, at the San
Bernardino County and Riverside County line. (PPNO 3009Q)

This project is located on I-10 from the 16th Street Overcrossing in Yucaipa to 0.2 miles east of the County Line Road Overcrossing in Calimesa. The San Bernardino County Transportation Authority (SBCTA), in cooperation with the Department, will extend the eastbound (EB) truck climbing lane on Interstate 10 within the above described project limits. The project is not fully funded. The project is currently programmed in the 2020 STIP for Plans, Specifications and

Estimates and Construction Capital for \$5,780,000. The project also includes local funding of \$9,298,000. The total project cost is estimated to be \$27,050,000 with construction estimate to begin in 2022-23. The scope, as described for the preferred alternative, is consistent with the project scope programmed by the Commission in the 2020 STIP.

A copy of the MND has been provided to Commission staff. The project will result in less than significant impacts to the environment after mitigation. The following resource areas may be impacted by the project: Geology and Soils. Avoidance and minimization measures will reduce any potential effects on the environment. These measures include, but are not limited to, preparation of a paleontological mitigation plan by a qualified Project Paleontologist/Principal Investigator prior to completion of the final project design phase for project-related ground disturbance in areas of paleontological sensitivity. As a result, an MND was completed for this project.

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

• Interstate 40 (I-40) in San Bernardino County. Regrade median cross slopes on I-40 in San Bernardino County. (PPNO 3002W)

The project is located on I-40, in San Bernardino County, from the Essex Road Overcrossing in the community of Fenner to 4.5 miles east of Homer Wash Bridge. The scope of this project is to regrade the existing median cross slopes, construct drainage modifications, and replace substandard metal beam guardrail. This project is fully funded and is currently programmed in the 2020 SHOPP for a total of \$40,106,000 which includes Construction (capital and support) and Right of Way (capital and support). 


