This project—along with the other rail projects listed as nominated but not recommended — will support the goals of the adopted 2018 California State Rail Plan and help California achieve its ambitious greenhouse gas emission reduction goals.

The King City Platform & Multimodal Station, Phase One project will provide new rail access to travelers on the Central Coast, including to the US Army Fort Hunter Liggett which serves approximately 50,000 visitors and soldiers annually. The project will promote economic development around the rail station and increase connectivity and access to jobs and services for low-income, minority communities – King City is a Census-defined disadvantaged community, largely comprised of Latino/Hispanic populations (87.5%), which has a citywide poverty rate of close to 20%, which is above state and federal poverty rates. This project provides an alternative to vehicular travel, thereby reducing vehicle miles traveled and greenhouse gas emissions while improving air quality.

SLCOOG appreciates the Commission's consideration of ITIP funding for the King City Rail Platform project as a critical improvement to facilitate the improvement of rail service along the Coast Route, and a means to support California's climate action and equity goals. Dear Chair Norton and Commissioners:

On behalf of the City of King, I want to express our appreciation that the City of King application for \$7.5 million in the 2022 Interregional Transportation Improvement Program (ITIP) is included in the posted resolution stating funding will be reserved.

This project is strongly supported by the California Department of Transportation (Caltrans), California State Transportation Agency (CalSTA) and Amtrak and a large portion of the preconstruction work has been completed. The ITIP funding is a crucial component to facilitate the improvement of rail service in our region and support the State climate action goals.

This project, King City (# 9890), and other rail projects, including CCJPA (#9886), LOSSAN (#9887), and SMART (#9889), are a crucial part of a strategic implementation plan to increase access, support the goals of the California State Rail Plan, and help the State achieve its ambitious greenhouse gas emission reduction goals. The staff recommendation to program and reserve funding for these projects will maximize our collective efforts. We appreciate and strongly support approval of staff's recommendations and accompanying resolution.

King City's application is supported by local and regional agencies, such as the Transportation Agency for Monterey County (TAMC), Monterey Bay Air Resources District (MBARD), Monterey-Salinas Transit (MST), Monterey County Board of Supervisors, Fort Hunter Liggett, and the Coast Rail Coordinating Council (CRCC). The goals of the King City Platform and Multimodal Transportation Center (MMTC) - Phase One project is supported by and is consistent with the Association of Monterey Bay Area Governments (AMBAG) 2040 Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS). In addition, Principal Host Railroad Development received a letter on February 25th from Union Pacific expressing their support for an additional station at King City, an important step in moving the project forward. The project is a collaborative team effort with these and other agencies to increase access along the central coast corridor.

This project also meets several Local, State, and Federal priorities and the proposed ITIP funds will support the construction of a train platform in downtown King City to enable a stop on the Coast Starlight in the near term. This grant will provide an alternative mode of transportation, enhance the City's active transportation efforts, help reduce vehicle miles travelled (VMT), reduce greenhouse gas (GHG) emissions improving our air quality, encourage Transit Oriented Developments (TOD) for much needed housing, promote economic development around the rail station, and increase connectivity and access to jobs and services for low-income, minority communities benefitting our underserved rural community and region.
