STIP RAIL/PROPOSITION 116 PROJECT

RESOLUTION MFP-22-01, AMENDING RESOLUTION MFP-21-07 RESOLUTION BFP-22-01, AMENDING RESOLUTION BFP-21-01

ISSUE:

Should the California Transportation Commission (Commission) approve an amendment for the locally-administered multi-funded State Transportation Improvement Program (STIP) Rail/Proposition 116 (P116) Stockton Regional Rail Maintenance Facility Expansion Project (PPNO 9884), in San Joaquin County, to add a Project ID for P116, change the program code of P116, increase the P116 amount by \$15,000, and decrease the State Highway Account (SHA) by \$15,000? There is no change to the overall allocation amount.

RECOMMENDATION:

The California Department of Transportation recommends the Commission approve an amendment for the locally-administered multi-funded STIP Rail/P116 Stockton Regional Rail Maintenance Facility Expansion Project (PPNO 9884), in San Joaquin County, to add a Project ID for P116, change the program code of P116, increase the P116 amount by \$15,000, and decrease the SHA by \$15,000. There is no change to the overall allocation amount.

BACKGROUND:

At the June 2022 meeting, the Commission approved Resolution MFP-21-07 and BFP-21-01 for the locally-administered multi-funded STIP Rail/P116 project to increase P116 by \$10,000 and decrease SHA by \$10,000, due to remaining P116 interest that was not accounted for in the close-out policy allocation. This amendment is to add a Project ID for P116, change the program code of the P116 component to align with similarly programmed projects, increase P116 by \$15,000 and decrease SHA by \$15,000, utilizing Surplus Money Investment Fund interest through June 30, 2022 for a net zero change. This is the final allocation amendment to
