Subject: <u>STIP AMENDMENT 22S-27 (NOTICE)</u> <u>PPNO 3L38A – SACRAMENTO COUNTY</u>

SUMMARY:

The California Department of Transportation (Department) will request that the California Transportation Commission (Commission) approve the requested State Transportation Improvement Program (STIP) amendment at the next scheduled Commission meeting following the notice period.

The Sacramento County (County) and Sacramento Area Council of Governments (SACOG) propose to amend the 2022 STIP to delay construction from Fiscal Year 2023-24 to 2024-25 for the Elverta Road Widening with Bridge Replacement at Dry Creek project (PPNO 3L38A), in Sacramento County.

BACKGROUND:

The Elverta Road Widening with Bridge Replacement at Dry Creek project (PPNO 3L38A) proposes to widen Elverta Road from two lanes to four lanes and install Class II bike facilities and a landscaped median. This project will replace the existing two-lane bridge with a wider six-lane (future) reinforced concrete bridge. The structure will include a raised median, an equestrian pathway, and Class II bike lanes and sidewalks to accommodate bicyclists and pedestrians, with the traffic signal at Elverta Road and 28th Street will also being modified. The purpose of this project is to enhance capacity, reduce congestion, improve multi-modal travel, and enhance safety and accessibility to surrounding neighborhoods.

The primary factor resulting in delays to the project is coordination with the Central Valley Flood Protection Board (CVFPB) and the impact of their decision to claim jurisdiction. When the project was initially programmed, CVFPB did not claim jurisdiction over Dry Creek, so its freeboard/clearance requirements were not factored into the bridge profile. Following several years of delay due to a lack of full project funding, CVFPB changed its position and now claims jurisdiction.

The past approximately 12 months were spent evaluating bridge profile designs and hydraulic analyses to meet the requirements of CVFPB. The County worked closely with CVFPB staff throughout this process. It was determined through several design iterations and subsequent analyses that the project cannot meet CVFPB freeboard/clearance requirements without adversely affecting properties both upstream and downstream. Therefore, the County has been coordinating with CVFPB to develop a revised bridge design, which is eligible for a waiver from CVFPB's freeboard/clearance requirements.

CVFPB indicated that the revised design is eligible for a waiver. However, the waiver must be approved by a CVFPB board action, which requires the project's California Environmental Quality Act document to be complete. The revised bridge design was not analyzed in the Final Environmental Impact Report (EIR). Therefore, the County must prepare a subsequent EIR for the current design before CVFPB can approve the waiver request. This effort is underway but will likely take approximately 12 months. An additional 6 months will be needed for CVFPB to agendize and approve the waiver following adoption of the subsequent EIR.

Therefore, the County and SACOG propose to delay construction of the Elverta Road Widening with Bridge Replacement at Dry Creek project (PPNO 3L38A), in Sacramento County from 2023-24 to 2024-25.
