Declaration for the Mariposa Creek Parkway Phase III and Trailhead Project,

Resolution E-23-66

Recommendation:

Staff recommends the California Transportation Commission (Commission), as a Responsible Agency, accept the Mitigated Negative Declaration for the Mariposa Creek Parkway Phase III and Trailhead Project (Project) in Mariposa County and approve the Project for future funding consideration

Issue:

Mariposa County (County) is the California Environmental Quality Act lead agency for the Project. The Project will construct a multi-use bicycle and pedestrian trail, including a pedestrian only secondary trail to interconnect segments of 8th Street, State Route 140/State Route 49, and the Joe Howard Bridge. The Project is located along Mariposa Creek in downtown Mariposa, Mariposa County.

For all projects that are anticipated to be funded through a program under the purview of the Commission, full compliance with the California Environmental Quality Act is required. The Commission will not allocate funds to projects for design, right-of-way, or construction until the environmental document is complete, and the Commission has approved the environmentally cleared project for future funding consideration.

Background:

On March 23, 2023, the Mariposa County Board of Supervisors adopted the Mitigated Negative Declaration for the Project and found that the Project would not have a significant effect on the environment after mitigation.

Impacts that require mitigation measures to be reduced to less than significant levels relate to aesthetics, biological and cultural resources, geology, hazardous materials and noise. Mitigation measures include the following: require that all outdoor lighting comply with International Dark Sky Association standards, conduct preconstruction surveys for the

protection of the Western Pond Turtle, cease construction activities and contract with a qualified archaeologist if Native American remains or artifacts are unearthed during construction, prepare a Sedimentation Control Plan, require fire-focused landscaping to minimize opportunities for wildfires, and install sound control devices on heavy equipment prior to construction.

On April 10, 2023, the County confirmed that the preferred alternative set forth in the final environmental document is consistent with the Project scope of work programmed by the Commission.

The Project is estimated to cost \$5,176,000 and is funded through construction with Active Transportation Program – Cycle V Funds (\$4,415,000) and Local Funds (\$761,000).

Construction is estimated to begin in fiscal year 2024-25.
