ISSUE:

Should the California Transportation Commission (Commission) approve an allocation of \$448,000 for two locally-administered State Transportation Improvement Program (STIP) projects, off the State Highway System, programmed in Fiscal Year 2023-24?

RECOMMENDATION:

The California Department of Transportation recommends that the Commission approve an allocation of \$448,000 for two locally-administered STIP projects off the State Highway System, programmed in 2023-24.

BACKGROUND:

The attached vote list describes two locally-administered STIP projects totaling \$448,000. The local agencies are ready to proceed with these projects, and are requesting an allocation at this time.

FINANCIAL RESOLUTION:
