Dear Ms. Taylor:

On behalf of SMART and our North Bay communities, thank you for your consideration of programming 2022 Solutions for Congested Corridors Program (SCCP) funds towards the completion of our extension to Windsor.

As indicated in the application requesting 2022 SCCP funds, Regional Measure 3 (RM3) legislative language identifies the SMART Extension from Sonoma County Airport to Windsor and Healdsburg as a capital project to receive \$40 million in RM3 bridge toll funds.

If SMART's Windsor Extension is programmed in the 2022 SCCP, SMART guarantees RM3 funds will be committed to completing the extension of SMART to Healdsburg. The Metropolitan Transportation Commission (MTC) is the entity responsible for distribution of RM3 funds and earlier this year SMART notified MTC staff that SMART will request allocation of RM3 funds for completion of SMART to Healdsburg. These RM3 funds were identified for SMART to Healdsburg in our 2024 Annual Budget and SMART has identified sufficient operating revenues for service to Healdsburg.
