Subject: MONTHLY STATUS OF CONSTRUCTION CONTRACT AWARD FOR LOCAL ASSISTANCE STIP PROGRAM PROJECTS, PER STIP GUIDELINES

ACTION UPDATE: Nine projects were removed from the project listing due to being deferred to August 2023 during the June 2023 meeting, as a result of the CRRSAA STIP funding being rescinded.

#### **SUMMARY:**

The California Department of Transportation (Department) is presenting this item for information purposes only. The item provides the status of locally-administered State Transportation Improvement Program (STIP) projects that received a construction allocation in Fiscal Year 2022-23.

In 2022-23, the Commission allocated \$63,063,000 to construct 29 locally-administered STIP projects. As of July 13, 2023, five projects totaling \$8,670,000 have been awarded. Two projects have concurrent time extension requests on the August 2023 Commission meeting agenda. Four projects are scheduled to award by their extended deadlines. The remaining 27 projects are scheduled to award by their deadlines.

#### **BACKGROUND:**

Current STIP Guidelines require projects to be ready to proceed to construction within six months of allocation. The policy also requires the Department to report to the Commission on those projects that have not been awarded within four months of allocation.
