# Consistency with the ITSP

- The Interregional Transportation Strategic Plan (ITSP) required under statute (SB 486, 2014)
- Framework that guides investment of ITIP funds
- Strategy for improvements to the entire interregional system, all funding sources
- Strategic Interregional Corridors indicate highest priority for ITIP investment



# Factors Used to Prioritize 2024 ITIP Projects

- Project cost and/or ITIP request amount (due to limited 2024 ITIP funding capacity)
- 2021 ITSP Evaluation Criteria for ITIP Projects
- Currently programmed ITIP projects that need funding to complete remaining phases
- Prioritizing new projects consistent with the ITSP and the CAPTI Framework



# 2024 Funding Capacity for ITIP

2024 STIP Fund Estimate

Provides ITIP \$312,076,000 in new capacity



## 2024 ITIP Proposal

#### **Carryover Projects**

Carry forward twenty-one 2022 ITIP projects into the 2024 ITIP. These projects carry forward their funding from 2022 ITIP in to the 2024 ITIP.

#### Cost Changes (\$134,961,000)

Fund subsequent phases for five carried over projects for a total of \$134,961,000

#### New Projects (\$186,621,000)

Program ten new projects that align with CAPTI & the 2021 ITSP in the 2024 ITIP for a total of \$186,621,000


