Subject: Approval of Project for Future Funding Consideration – Mitigated Negative Declaration for the Road M1/2 Rehabilitation and Reconstruction Project, Resolution #E-24-12

UPDATE: The replacement book item includes, in this memorandum and in Attachment A, the City of Orland's approval date of the Mitigated Negative Declaration and the City's confirmation that the environmental document remains valid; there are no new impacts requiring mitigation; and the project in the environmental document is consistent with the Project's scope of work programmed by the Commission.

Recommendation:

Staff recommends the California Transportation Commission (Commission), as a Responsible Agency, accept the Mitigated Negative Declaration for the Road M 1/2 Rehabilitation and Reconstruction Project (Project) in the City of Orland in Glenn County and approve the Project for future funding consideration.

<u>lssue:</u>

The City of Orland is the California Environmental Quality Act Lead Agency for the Project. The Project will consist of reconstruction and rehabilitation of Road M1/2, resulting in a new surface, a new curb and gutter, a new sidewalk and Americans with Disabilities Act-compliant ramps, improved utilities, and a new box culvert for improved drainage. The Project is located on Road M1/2 between Bryant Street and State Route 32 in the City of Orland in Glenn County.

For all projects that are anticipated to be funded through a program under the purview of the Commission, full compliance with the California Environmental Quality Act (CEQA) is required. The Commission will not allocate funds to projects for design, right-of-way, or construction until the environmental document is complete, and the Commission has approved the environmentally cleared project for future funding consideration.

Background:

On January 23, 2024, the City of Orland's City Council adopted the Mitigated Negative Declaration for the Project and found the Project would not have a significant effect on the environment after mitigation. On January 23, 2024, the City of Orland confirmed that the environmental document remains valid; there are no new impacts requiring mitigation; and the Project set forth in the environmental document is consistent with the Project's scope of work programmed by the Commission.

Impacts that require mitigation measures to be reduced to less than significant levels relate to biological resources, cultural resources, and geology and soils. Mitigation measures include erosion control measures and Best Management Practices during construction; Worker Environmental Awareness training; avoidance of nesting season or implementation of nesting bird surveys; measures for inadvertent discovery of cultural resources during construction; and use of a qualified paleontologist if paleontological or geologically sensitive resources are identified during development on the project site.

The Project is estimated to cost \$1,065,000 in total and is funded through construction through the State Transportation Improvement Program (\$1,065,000).

Construction is scheduled to begin in Fiscal Year 2024-25.


