# Aligns with the CAPTI & ITSP

- The Interregional Transportation Strategic Plan (ITSP) is required under statute (SB 486, 2014)
- Framework that guides investment of ITIP funds
- Strategy for capital improvements to the entire interregional system, all funding sources
- Strategic Interregional Corridors indicate highest priority for ITIP investment



### Factors Used to Prioritize 2024 ITIP Projects

- Project cost and/or ITIP request amount (due to limited 2024 ITIP funding capacity)
- 2021 ITSP Evaluation Criteria
- Currently programmed ITIP projects that have cost updates/refinements or need funding to complete the remaining phases
- Prioritizing new projects consistent with the ITSP and the CAPTI Framework



# 2024 Funding Capacity for ITIP

2024 STIP Fund Estimate

Provides ITIP \$312 million in new capacity



## FINAL 2024 ITIP Includes:

### CARRYOVER PROJECTS

### COST UPDATES

#### NEW PROJECTS

Carrying forward 21 projects from the 2022 ITIP into the 2024 ITIP for a total amount of \$311.4 million.

Funding subsequent phases for five carried-over projects for a total of  $\approx$  \$135 million. Funding 9 new projects that align with CAPTI & the 2021 ITSP for a total of \$184.7 million.



## Summary of the Final 2024 ITIP:

Caltrans has proposed funding for the following projects:

- Four passenger rail
- Three active transportation
- Two new highway

Final 2024 ITIP presents a tremendous opportunity to align priorities and projects with the CAPTI and ITSP, which are two of the State's overarching and guiding planning documents.
