ISSUE:

Should the California Transportation Commission (Commission) approve an allocation of \$300,000 for the locally-administered State Transportation Improvement Program (STIP) State Route 1 - Freedom to State Park Auxiliary Lanes and Bus on Shoulders project (PPNO 0073D), on the State Highway System, in Santa Cruz County?

RECOMMENDATION:

The California Department of Transportation recommends that the Commission approve an allocation of \$300,000 for the locally-administered STIP State Route 1 - Freedom to State Park Auxiliary Lanes and Bus on Shoulders project (PPNO 0073D), on the State Highway System, in Santa Cruz County.
