To Whom It May Concern:

As the owner of Lakeview Supermarket and Deli, a cornerstone of the Lucerne, CA community that provides essential groceries and deli services to locals and visitors alike, I am writing to express my strong support for the Lake 29 Konocti Corridor Improvement Project. This initiative is not just a roadway improvement project; it is a beacon of progress for our community and the surrounding areas, promising to enhance the quality of life and safety for all.

The heavy traffic flow on State Route 20 (SR 20) through our north shore communities, including Lucerne, has been a longstanding concern for us. The mix of interregional and truck traffic navigating through our "Main Street" has significantly affected pedestrian and bicycle safety, contributed to increased noise levels, and impacted the overall quality of life negatively. The designation of this segment as a Pedestrian Safety Corridor in 2007 was a step in the right direction, yet the need for a more comprehensive solution has become ever more apparent.

As a resident of Lake County for over 54-years, with over 47 years on the Northshore I have seen an unbelievable number of incredible accidents, both fatal and shocking. In just the last year or so we had two 45 ft semi-trucks tip over on the very street where the elementary school sits. One time was a lumber truck that lost the entire load. The second incident was a hay hauler who likewise lost most of the bales which were scattered all over Highway 20. Just North in Nice, CA the number of pedestrians killed due to poor lighting and traditional dark clothing, has been alarming. Just last month our local mortician reported three deaths of pedestrians in that area. Not too long ago a semi-truck killed a person in a wheel chair.

In previous meetings of the Area Planning Council, I have been pushing for reflective arm bands to be distributed by local convenience stores to help stop the carnage. Often times the only thing protecting the locals on the fog line from death is the white grocery bag they often carry. Local lighting improvements will certainly be a plus but the trucks that pour through our communities every day are a serious concern. This is especially true at frequent pedestrian crossings where a 45-foot truck is forced to suddenly brake for a thoughtless person.

The Lake 29 Konocti Corridor Improvement Project will offer a huge improvement by proposing to reroute the interregional traffic onto the SR 20/29/53 Principal Arterial Route. This strategic redirection is expected to bring a multitude of benefits, including reduced traffic congestion in our community, improved safety for pedestrians and bicyclists, and a quieter, more peaceful environment for residents and businesses.

From a business perspective, the positive implications of this project are clear. For Lakeview Supermarket and Deli, improved traffic conditions mean not only a safer environment for our

customers but also an enhanced shopping experience. We anticipate that the reduction in traffic noise and congestion will make Lucerne an even more attractive destination for visitors, potentially boosting local commerce and bringing new customers to our doorstep. What's more, is that more than a few lives will be saved in the process!

The efforts of Caltrans to prioritize traffic calming and active transportation improvements have my full endorsement, and the Lake 29 Konocti Corridor Improvement Project is a crucial step towards achieving these objectives. Thank you for considering the perspective of a local business owner.

Madam Chairwoman:

The Fresno County Transportation Authority strongly supports Fresno Council of Governments' request to program \$42.3 million in new Regional Transportation Improvement Program apportionment on the American Avenue Interchange project at State Route 99 in Fresno County.

This project is being developed concurrently with the North/Cedar Avenue interchange roughly two miles to the north in an area zoned for the last 50-plus years for industrial development and that has recently seen rapid expansion of logistics centers and warehousing. The two interchanges proposed for improvement are original half-interchanges dating back to the mid-1960s that can no longer serve their function.

Nevertheless, this proposal is not about economic development. Both projects represent a major safety concern for Caltrans and the region. For the ten-year period from July 1, 2010, to June 30, 2020, there were 943 collisions on mainline SR 99 and the interchange ramps within the project limits. There were five fatalities and 280 injury accidents.

There have been 407 collisions within the project limits during the three-year period ending December 31, 2019. Of those, 120 resulted in injuries with no fatalities. The rate of injury plus fatal collisions is higher than the statewide average for similar facilities. The rate of total collisions (fatal, injury, and property damage only) is also higher than the statewide average. The standard Caltrans cost values for the various collision types demonstrates a three-year collision cost of just over \$21 million.

The proposed improvements at the American Avenue interchange include roundabouts at the ramp intersections. The roundabouts have added safety features to help reduce collision severity and provide improved pedestrian crossings. Multi-use paths will run adjacent to the roundabouts, which will provide a safe route for both pedestrians and cyclists.

Bike lanes will also be added along American Avenue through the interchange. Adding bike lanes where there is currently a gap in infrastructure, coupled with the increased lighting, will help to reduce the collisions occurring during the dark/dawn hours. Class II bike lanes will be added on North Avenue and the adjacent local roads, which will provide a dedicated path of travel for cyclists. These lanes are

consistent with both the City and County of Fresno's comprehensive Active Transportation Plans (ATP). Up to 10,000 feet of both new sidewalk and bike lanes will be added to the interchange crossroads and adjacent roads as part of this project. These improvements are intended to provide key connectivity to other planned ATP facilities.

In addition, the project will leverage several measures to reduce GHG emissions, and potential climate change impacts, including: active transportation facilities, travel demand management strategies, electrification, and air pollution control standards. This design connects to adjacent facilities to further enable active transportation and reduce emissions. Including active transportation facilities is a response to community requests.

The project design also incorporates and compliments zero-emission infrastructure being planned in coordination with the City of Fresno. Electric-vehicle charging stations will be included to improve air quality and reduce greenhouse gas emissions.

Fresno County Transportation Authority advocates the Commission to grant this important request for additional RTIP funding to complement the \$45.3 million in STIP funding already authorized by the CTC for the North/Cedar interchange, helping standardize these two interchanges and resolving major safety concerns on State Route 99 are long overdue.

The Central Coast Coalition strongly supports the California Transportation Commission (CTC) staff recommendations for the 2024 State Transportation Improvement Program (STIP). We thank Commission staff for their collaborative effort to work with the California Department of Transportation and California's Regional Transportation Planning Agencies on our submittals to the CTC.

As the area's Regional Transportation Planning Agencies in San Benito, Santa Cruz, Monterey, San Luis Obispo, and Santa Barbara counties, with the Association of Monterey Bay Area Governments, we highly value the STIP revenues and the investment by the CTC.
