
Cumulative Number of Bridges Fixed




Figure 20 – Cumulative Total Number of Bridges Fixed to Date Above the Baseline








INVENTORY AGE AND CONDITION




Figure 17 - Transportation Management Systems, Poor





Figure 15 - Drainage, Poor
