#### Subject: STATUS OF CONSTRUCTION CONTRACT AWARD FOR STATE HIGHWAY PROJECTS

#### SUMMARY:

The California Department of Transportation (Department) is presenting this Information Item to provide the status of construction contract award for projects on the State Highway System allocated in Fiscal Years 2022-23, and 2023-24.

In 2022-23, the California Transportation Commission (Commission) allocated \$3.82 billion to construct 495 State-Administered State Transportation Improvement Program (STIP), and State Highway Operation and Protection Program (SHOPP) projects on the State Highway System. As of July 8, 2024, 492 projects totaling \$4.47 billion have been awarded, two projects have lapsed, and the Department plans to re-program their Construction phase, and one project has an approved time extension and should be awarded by its extended deadline.

In 2023-24, the Commission allocated \$4.18 billion to construct 466 State-Administered STIP, and SHOPP projects on the State Highway System. As of July 8, 2024, 333 projects totaling \$2.90 billion have been awarded, two projects have lapsed, and the Department plans to re-program their Construction phases, 8 projects have concurrent time extensions, 8 projects have approved time extensions, and the remaining 115 projects should be awarded by their original deadlines.

#### BACKGROUND:

In accordance with STIP and SHOPP Guidelines, projects are required to be ready to proceed to construction within six months of allocation.
