Subject: **MONTHLY STATUS OF CONSTRUCTION CONTRACT AWARD FOR LOCAL ASSISTANCE STIP PROGRAM PROJECTS, PER STIP GUIDELINES**

SUMMARY:

The California Department of Transportation (Department) is presenting this item for information purposes only. The item provides the status of locally-administered State Transportation Improvement Program (STIP) projects that received a construction allocation in Fiscal Year 2024-25 and 2025-26.

In 2024-25, the California Transportation Commission (Commission) allocated \$14,426,000 to construct 12 locally-administered STIP projects. As of February 12, 2026, 12 projects totaling \$14,426,000 have been awarded.

In 2025-26, the Commission allocated \$25,134,000 to construct 13 locally-administered STIP projects. As of February 12, 2026, the projects are scheduled to award by their deadlines.

BACKGROUND:

Current STIP Guidelines (Guidelines) require projects to be ready to proceed to construction within six months of allocation. The Guidelines also require the Department to report to the Commission on those projects that have not been awarded within four months of allocation.
