ISSUE:

Should the California Transportation Commission (Commission) approve an allocation amendment for the locally-administered State Transportation Improvement Program (STIP) E Whitlock Road Rehabilitation project (PPNO 3551), off the State Highway System, in Mariposa County, to revise the project description?

RECOMMENDATION:

The California Department of Transportation recommends that the Commission approve an allocation amendment for the locally-administered STIP E Whitlock Road Rehabilitation project (PPNO 3551), off the State Highway System, in Mariposa County, to revise the project description.

BACKGROUND:

In May 2026, the Commission approved \$830,000 for the Construction phase of the locally-administered STIP E Whitlock Road Rehabilitation project (PPNO 3551), under Resolution FP-25-94. At the time of allocation, the project description was inadvertently listed incorrectly in the vote box as Hot Mix Asphalt (HMA) instead of chip seal. The project was programmed as a chip seal rehabilitation project. Therefore, the responsible agency is requesting this allocation amendment to revise the project description accordingly. The proposed change is reflected in strikethrough and bold in the attached revised vote box. There is no change to the scope or allocation amount.
