## How do we define environmental justice?

### Our environment is our built, social, and natural surroundings that impact our lives everyday.

WE, THE PEOPLE OF COLOR, gathered loggeher at this multinational People of Color Environmenta Leadership of Summit to begin to hild a national and international movement of all peoples of color to fight the destruction and taking or our lands and communities, do hereby re-setabilish our spiritual interdependence to the sacredness of our Mother Earth; to respect and celebra each of our cultures, languages and beliefs about the nature Mord and our roles in healing ourselves; to insure environmental justice; to promote economic alternatives which would contribute to the development of environmentally again (ivelification), resulting in the poisoning of our communities and land and the genecide of our popoles, do affirm and adopt these Princips of Environmental basice;

#### The Principles of Environmental Justice (EJ)

 Environmental Justice affirms the sacredness of Mother Earth, ecological unity and the interdependence of all species, and the right to be free from ecological destruction.

 Environmental Justice demands that public policy be based on mutual respect and justice for all peoples, free from any form of discrimination or bias.

3) Environmental Justice mandates the right to ethical, balanced and responsible uses of land and renewable resources in the interest of a sustainable planet for humans and other living things.

4) Environmental Justice calls for universal protection from nuclear testing, extraction, production and disposal of toxic/hazardous wastes and poisons and nuclear testing that threaten the fundamental right to clean air, land, water, and food.

 Environmental Justice affirms the fundamental right to political, economic, cultural and environmental selfdetermination of all peoples.

6) Environmental Justice demands the cessation of the production of all toxins, hazardous wastes, and radioactive materials, and that all past and current producers be held strictly accountable to the people for detoxification and the containment at the point of production.

 Environmental Justice demands the right to participate as equal partners at every level of decisionmaking, including needs assessment, planning, implementation, enforcement and evaluation.

8) Environmental Justice affirms the right of all workers to a safe and healthy work environment without being forced to choose between an unsafe livelihood and unemployment. It also affirms the right of those who work at home to be free from environmental hazards.

9) Environmental Justice protects the right of victims of environmental injustice to receive full compensation and reparations for damages as well as quality health care. 10) Environmental Justice considers governmental acts of environmental injustice a violation of international law, the Universal Declaration On Human Rights, and the United Nations Convention on Genocide.
11) Environmental Justice must recognize a special legal and natural relationship of Native Peoples to the U.S.

government through treaties, agreements, compacts, and covenants affirming sovereignty and self-determination. 12) Environmental Justice affirms the need for urban and trural ecological policies to clean up and rebuild our cities and rural areas in balance with nature, honoring the cultural integrity of all our communities, and provided fair

access for all to the full range of resources. 13) Environmental Justice calls for the strict enforcement of principles of informed consent, and a halt to the testing of experimental reproductive and medical procedures and vaccinations on people of color.

 Environmental Justice opposes the destructive operations of multi-national corporations.

15) Environmental Justice opposes military occupation, repression and exploitation of lands, peoples and cultures, and other life forms.

16) Environmental Justice calls for the education of present and future generations which emphasizes social and environmental issues, based on our experience and an appreciation of our diverse cultural perspectives.

17) Environmental Justice requires that we, as individuals, make personal and consumer choices to consume as little of Mother Earth's resources and to produce as little waste as possible; and make the conscious decision to challenge and reprioritize our lifestyles to insure the health of the natural world for present and future generations.

Delegates to the First National People of Color Environmental Leadership Summit held on October 24-27, 1991, in Washington DC, drafted and adopted 17 principles of Environmental Justice. Since then, The Principles have served as a defining document for the growing grassroots movement for environmental Justice. "Once you start making these linkages, you can no longer do just tree planting. When you start working with the environment seriously, the whole arena comes: human rights, women's rights, environmental rights, children's rights...everybody's rights"

## **Environmental Justice Issues in the IE**



The Inland Valley Region of Southern California has long faced EJ issues that impact our marginalized, BIPOC, low income communities.

Main EJ issues include: air quality, water quality, and land use.

- Air Quality: Logistics Industry, warehousing, railyards, airports, freeways
- Water quality: PFAS, forever chemicals, military bases, toxic runoff
- Land Use/Transportation: Lack of open space/green spaces, preservation of natural areas, land zoning, public transit, truck routes



An estimated 40% of the nation's consumer goods come through the region, <u>Bloomberg</u> News reported, and the logistics industry employed almost 1 in 8 Inland workers as of early 2021.



## Fighting for Sustainability in our Communities

Our focus is on <u>organizing</u> to build community power and leadership through community education, civic engagement and policy.

Recent campaigns:

- <u>Warehouse Indirect Source Rule</u> Successfully campaigned to make our local air quality management district hold warehouses accountable for their emissions.
- <u>Railyard Indirect Source Rule</u> This past month the EPA voted to allow local agencies to regulate railyards and this past week our local agency voted to force railyards to regulate their emissions.
- <u>Local Warehouse Moratoriums</u> Fought and won in cities like Colton, Jurupa Valley, and Redlands to stop all warehouse development and allow for studies on the impacts of the logistics industry
- <u>AB 1000</u> ASM Eloise Reyes sponsored a bill to create a 1000 ft buffer between warehouse development and sensitive receptors like homes, schools, hospitals, parks, etc.
- <u>Region in Crisis</u> Demand letter to the governor to place a 2 year moratorium on warehouse development the entire Inland Valley region to allow for comprehensive studies on the cumulative impacts of the industry on our communities.
