## SUBCOMMITTEE BACKGROUND

## Interagency Equity

## Section 5.4 Subcommittees

The Committee may form permanent and ad hoc subcommittees. The Committee can delegate to a subcommittee the power to make a recommendation on behalf of the entire Committee.

Permanent subcommittees may be formed by amendment of this Charter, and must be approved by CalSTA, the Commission, and Caltrans.

Ad hoc subcommittees may be formed by the Chair or by a majority vote of the Committee as needed. Ad hoc subcommittees will dissolve once the purpose of the subcommittee has been achieved or one year from their formation, whichever is earlier.

The Committee's Chair is an ex officio member of all subcommittees but has no vote. The Chair may delegate to the Vice Chair(s) the Chair's ex officio membership on any subcommittee.

## Key Considerations

- The Committee serves in an advisory capacity to the Commission, Caltrans, and CalSTA, and can create subcommittees, either permanent or ad hoc, that make advisory recommendations to the entire Committee.
- A group of three or more members (including Chair and Vice Chair) cannot meet without a publiclynoticed meeting.
- The Committee can approve policy recommendations to any of the three agencies with a super majority (two-thirds of members).
- A subcommittee is not required for the Committee to propose a motion and vote on a policy recommendation consistent with Bagley- Keene requirements.


## Other Things to Consider

1. The subcommittee structure falls within the scope of the EAC as approved by Caltrans, CalSTA, and the Commission.
2. Focus areas are identified in the interagency workplan (ref. slide 8).
3. Most, but not all, EAC members are interested and have capacity to serve on subcommittees.
4. Interagency staff have adequate capacity to support subcommittee activities (For example, 1-2 subcommittee convenings between EAC meetings).
5. Not all members must participate in a subcommittee and not all focus areas or workplan items must be supported by a subcommittee.

## Permanent Subcommittees

- Analyze ongoing issues that require attention for a long period of time or are recurring
- Requires Charter amendment and interagency executive and Commission approval


## Examples

- Community and District-level engagement or communications
- Updating funding program guidelines which requires an iterative process


## Ad hoc Subcommittees

- Temporary
- Purpose is completed in a short amount of time
- Does not require Charter amendment


## Examples

- Support planning or funding program guidelines development
- Funding program application review
- Research on issue-areas to be presented at an upcoming meeting


## Alternatives to Subcommittees

- Brown bag lunches
- Educational workshops and briefings
- District tours for learning and engagement

Note: All options will be noticed pursuant to Bagley-Keene.

## Process for Getting Started: Ad Hoc Subcommittees

1. Subcommittee(s) are established by Committee vote or Chair.
2. If the subcommittee consists of more than two Committee members (including Chair or Vice-Chair), staff will schedule a meeting on behalf of the subcommittee to convene before the next Committee meeting or other relevant deadline, whichever is earlier.
3. Subcommittee members will have an agenda item at the next Committee meeting to report on their efforts and share any recommendations for adoption by the Committee.
