# 2025 Committee Work Plan – Overview

<b>State Transportation Improvement Program 2026 Guidelines Review</b>  [Subject Matter Experts]	Members are reviewing the 2026 Draft Guidelines and providing feedback to staff via member briefings.	Member feedback will be incorporated into the updated Program Guidelines for 2026.	This program allocates funding to state highway, active transportation, intercity rail, and transit improvements throughout California.	April - May 2025
<b>Senate Bill 1 Funding Program Application Evaluation</b>  [Subject Matter Experts]	Members are supporting the project application evaluation process for the competitive Senate Bill 1 (SB 1) Funding Programs through the evaluation of applicants' community engagement narratives.	Program staff incorporate EAC member evaluation ratings into funding recommendations. EAC members can also provide feedback to Commission staff on how applicants can improve community engagement strategies.	Also known as the <a href="#">Road Repair and Accountability Act of 2017</a> , the funding programs under SB 1 address multi-modal transportation needs across the state.  Member involvement influences Commission adoption of \$1.5 billion in transportation projects.	Spring 2025

The Director's Policy aims to improve Caltrans' transparency, alignment, and responsiveness to community needs throughout the transportation planning and project development process. Provide input on the selection of projects such as ADA-accessible vehicles and mobility management funding.	<p>Improve the mobility of seniors and individuals with disabilities by removing barriers to transportation services and expanding transportation options to meet specialized needs.</p> <p>Caltrans administers roughly \$29.3 Million to large urbanized areas and \$22.3 Million to small and rural communities.</p>	Summer / Fall 2025

Guide policy recommendations to grow transit ridership, improve the transit experience, and address long-term operational needs.	Summer/Fall 2025
<b>Port and Freight Infrastructure Program (PFIP)</b> [Ad Hoc Subcommittee]	Members will provide insights about the impacts of the PFIP to surrounding communities and economies.	Inform PFIP's goals of transportation equity and environmental justice, avoiding public health harms, moving toward zero freight-related deaths and injuries, and improving system resilience.	The PFIP seeks to improve the capacity, safety, efficiency and resilience of goods movement through California's ports, while reducing emissions, public health impacts, and negative economic impacts.	Fall 2025

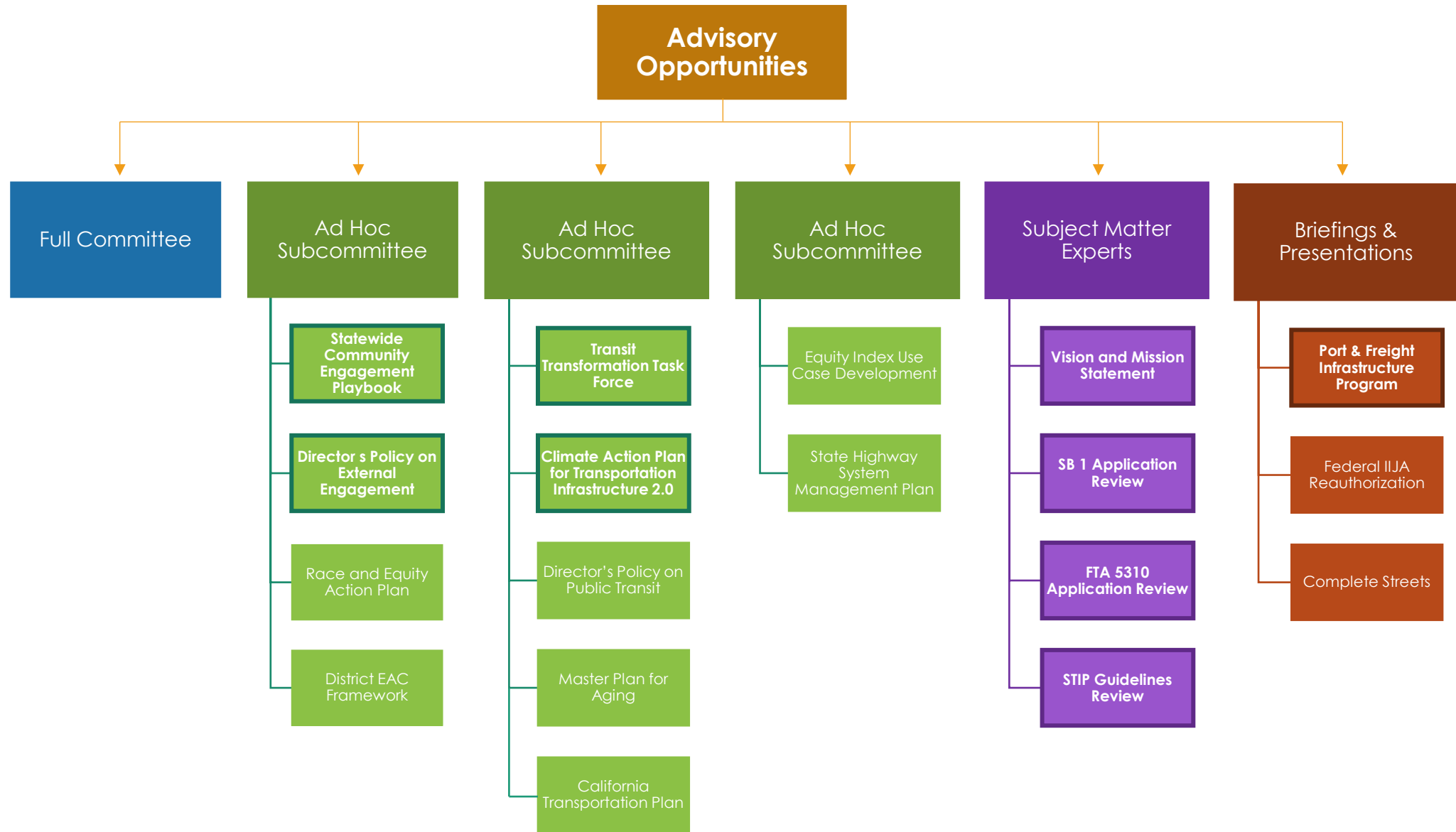

<b>Climate Action Plan for Transportation Infrastructure (CAPTI) 2.0</b>  [Ad Hoc Subcommittee]	Ongoing work to implement CAPTI 2.0 will be initiated as opportunities arise based on identified actions and lead agencies. For example, SB 1 guidelines brought forth by the CTC.	The Committee will continue to leverage existing efforts to recommend CAPTI 2.0 actions, evaluation, and investment to address vehicle miles traveled, greenhouse gas emissions, equity, and economic outcomes.	CAPTI 2.0 provides a holistic framework that aligns the state's transportation infrastructure investments with the state's climate, health, and social equity goals.	Fall 2025
