#### **Project Size Thresholds**



- Thresholds apply to infrastructure and combination infrastructure + non-infrastructure projects.
- Based on total project cost.
- Current thresholds:
  - Small: \$3.5 million or less
  - Medium: Over \$3.5 million up to \$10 million
  - Large: Over \$10 million
- Discussion:
  - Should we change these thresholds? Why or why not?
  - If we were to change them, what would be reasonable thresholds?

#### Large Project Cap



- Stakeholder suggestion: Put a cap on the number or amount of funding for "mega" projects funded through the ATP.
- Currently, projects are funded in order of score, regardless of project size or request amount.
  - Under this proposal, once the cap is met, remaining "mega" projects would no longer be considered and lower scoring projects would be funded.
- <u>Discussion:</u>
  - Do stakeholders support this idea?
  - If so:
    - What is the definition of a "mega" project?
    - What is a reasonable cap?





- Applicants can earn up to 5 points in the medium and large application for non-ATP funds pledged to the project.
- Goal is to encourage agencies to commit local funds to priority projects.
- Funds allocated by the Commission on a project-specific basis are not eligible for leveraging points, except STIP funds, which are eligible.
- In-kind and non-infrastructure funds are not eligible for leveraging points.
- Applicants are required submit a letter of commitment.
