Subject: Approval of the 2023 California Natural Resources Agency's

Environmental Enhancement and Mitigation Program, Resolution G-24-33

Recommendation:

Staff recommends that the California Transportation Commission (Commission) approve the 2023 Environmental Enhancement and Mitigation Program, which includes eight projects totaling \$9,350,924 as provided in Attachment B, with the following stipulations:

- The Commission expects that the funds allocated will be expended timely.
- For land acquisition projects, funding recipients are encouraged to reduce overall
 project costs by exploring the feasibility of acquiring easements rather than fee title
 when appropriate.
- Due to the uniqueness of the individual projects in this program, the California Natural Resources Agency must provide on-site inspection and auditing of the projects included in the program.

Issue:

The California Natural Resources Agency's evaluation team used the Environmental Enhancement and Mitigation Program procedures and criteria to evaluate 15 applications received as part of the 2023 grant cycle. As a result:

- Eight projects totaling \$9,350,924 are recommended for funding in the 2023 grant cycle.
 - 57 percent of the available funding is recommended for four projects in Northern California, totaling \$5,373,937.
 - 43 percent of the available funding is recommended for four projects in Southern California, totaling \$3,976,987.
- Seven projects were not recommended for award because they were either ineligible to compete or not competitive. These projects provided no environmental mitigation benefits, no link to the related transportation facility, or a weak connection to the related transportation facility for mitigation and benefits.
 - o One project in Northern California, totaling \$205,000.
 - Six projects in Southern California, totaling \$4,574,159.

The California Natural Resources Agency proposes to use project cost savings and the remaining funds from the 2022 grant cycle to fund the 2023 grant cycle, which is oversubscribed.

The funding available to the California Natural Resources Agency for the 2023 grant cycle is from the following sources: \$6,700,000 from the Budget Act of 2023, \$2,534,511 from the Budget Act of 2022, and \$116,413 from the Budget Act of 2018.

As the California Environmental Quality Act (CEQA) Lead Agency, the California Natural Resources Agency determined all eight projects are Categorically Exempt from CEQA and filed Notices of Exemption for each project.

Recommended Project Highlights:

El Rancho Unified Emerald Necklace Natural Infrastructure High School Complex (\$735,459) - The Amigos de los Rios is an urban forest project that will plant 250 trees and 1,500 shrubs, all native and Mediterranean, at the approximately 56-acre El Rancho Unified School District High School complex comprising El Rancho High School, Ruben Salazar Continuation High School, and El Rancho Adult School. They will host events inviting students, Conservation Corps members, and community stakeholders to plant and care for the plants. This project will provide multiple benefits by capturing stormwater and runoff and create habitat and recreational opportunities.

Tiburon Ridge (Martha Property) Acquisition (\$1,500,000) - The Trust for Public Land is a resource lands project that will acquire in-fee the 110-acre Martha Property near the tip of the Tiburon Peninsula. The property offers well-established social trails and wildlife corridors, native grassland, and wetland habitats that support five special status species. The project will permanently prevent development and protect, in perpetuity, coastal live oak woodland, freshwater wetland, and California red-legged frog upland habitat. The community has been working to protect the property for more than three decades. Ownership will be transferred to the Marin County Open Space District for management as a public open space preserve. The project provides enhanced mitigation for the construction impacts of adding two carpool lanes on 16-miles of the US101 Marin Sonoma Narrows related transportation facility.

Background:

The Environmental Enhancement and Mitigation Program was established by the state Legislature in 1989 to fund environmental enhancement and mitigation projects directly or indirectly related to the environmental impact of modifying new or existing transportation facilities. Pursuant to Streets and Highways Code Section 164.56, seven million dollars (\$7,000,000) is appropriated annually to the program from the State Highway Account. The Commission awards annual grants to fund projects as recommended by the California Natural Resources Agency.

The California Natural Resources Agency develops and adopts procedures to determine eligibility, evaluate project proposals, recommend projects for funding to the Commission, and manage the grants post award. Any local, state, or federal agency, or nonprofit entity may apply for and receive funding to undertake environmental enhancement and mitigation projects. Eligible projects must fit at least one of the following three categories:

- 1. **Urban Forestry** projects designed to offset vehicular emissions of carbon dioxide.
- Resource Lands projects for acquisition or enhancement of resource lands to mitigate
 the loss of, or the detriment to, resource lands lying within the right-of-way acquired for
 proposed transportation improvements.
- 3. Mitigation Projects Beyond the Scope of the Lead Agency projects to mitigate the impact of proposed transportation facilities or to enhance the environment, where the ability to effectuate the mitigation or enhancement measures is beyond the scope of the lead agency responsible for assessing the environmental impact of the proposed transportation improvement.

Pursuant to Streets and Highways Code Sections 187 and 188, the California Natural Resources Agency tries to award 40 percent of the total funding to projects in northern counties and 60 percent of the total funding to projects in southern counties. The percentages vary slightly each year depending on the applicant pool.



- 2.1 **NOW, THEREFORE, BE IT RESOLVED**, that the Commission approves the 2023 Environmental Enhancement and Mitigation Program, as indicated in Attachment B; and
- 2.2 **BE IT FURTHER RESOLVED**, that for projects which include land acquisition, the Commission encourages funding recipients to reduce overall project costs by exploring the feasibility of acquiring easements rather than fee title when appropriate; and
- 2.3 **BE IT FURTHER RESOLVED**, that due to the uniqueness of the individual projects in this program, the Commission recommends the California Natural Resources Agency provide on-site inspection and auditing of the projects included in this program.

As provided in Section 164.56 of the Streets and Highways Code, the California Natural Resources Agency (Agency) has evaluated the 2023 Environmental Enhancement and Mitigation (EEM) program grant proposals and provided the attached recommendations. Projects on the Recommended for Funding List meet the statutory requirements and contribute to the mitigation of the environmental effects of transportation facilities.

Agency recommends that the projects on the Recommended for Funding List be authorized to receive immediate funding. These recommendations were determined by a multi-disciplined evaluation team. The list includes 8 projects with a total value of \$9,350,923 which includes \$116,412.55 from a project that was terminated, \$2,534,511 rolled over from 2022, and \$6,700,000 from the 2023 appropriation.

ENVIRONMENTAL ENHANCEMENT AND MITIGATION GRANT

2023 GRANT CYCLE

RECOMMENDATION

Approve grants for 8 projects totaling 9,350,924.

BACKGROUND

Under Streets and Highways Code Section 164.56(a), the California Transportation Commission (Commission) is charged with the responsibility of funding an annual Environmental Enhancement and Mitigation (EEM) Program administered by the California Natural Resources Agency (Agency) at the funding level provided in the State Budget.

The EEM Program awards grants to environmental enhancement and mitigation projects that are directly or indirectly related to the environmental impact of modifying existing transportation facilities or the design, construction, or expansion of new transportation facilities.

California Streets and Highways Code Section 164.56 (as amended in 2013, SB 99) provides for grants to be awarded in three categories:

- <u>Urban Forestry</u>: Projects designed to offset vehicular emissions of carbon dioxide.
- Resource Lands: Acquisition or enhancement of resource lands to mitigate the loss
 of, or the detriment to, resource lands lying within the right-of-way acquired for
 proposed transportation improvements.
- <u>Mitigation Projects Beyond the Scope of the Lead Agency</u>: Projects to mitigate the
 impact of proposed transportation facilities or to enhance the environment, where
 the ability to effectuate the mitigation or enhancement measures is beyond the
 scope of the lead agency responsible for assessing the environmental impact of
 the proposed transportation improvement.

Agency is responsible for developing and adopting guidelines (procedures and criteria) and determining eligibility, evaluating proposals, recommending projects for funding, and managing grants post awards. Agency's procedures and criteria contain a scoring mechanism to evaluate projects by assigning point scores to each project. Projects making the initial cut are then visited for further vetting. In accordance with the provisions of Section 187 and 188 of the Streets and Highways Code, Agency attempts to allocate 40% of the total amount recommended to projects in northern counties and 60% to projects in southern counties. The percentages vary slightly year to year depending on the pool of applications and competitiveness.

AVAILABLE FUNDING 2023

Funds are available from the 2023 appropriation for 6,700,000 and from the 2022 appropriation 2,534,511, which represents 1,634,511 rolled over from 2022 and 900,000 from a 2022 grant terminated due to lack of leveraged funding. An additional 116,413 from 2018-19 appropriation has been added for a total of 9,350,924 available to award.

CEQA

Notice of Exemptions has been filed for all eight projects recommended for funding.

HIGHLIGHTED PROJECTS

- The City of Torrance will plant 121 native trees within the Cabrillo Avenue median between 213th Street to the north and Plaza del Amo to the south in Downtown Torrance. The City will also install a smart irrigation system and replace asphalt with a permeable surface to increase infiltration. The project provides enhanced mitigation for the construction of the Del Amo Blvd Extension project.
- The Mountains and Recreation Conservation Authority (MRCA) will acquire in-fee, the 31.24-acre Paradise Hill property within the City of Los Angeles. The project will permanently protect the property from development, will protect the grasslands, Southern California black walnut trees, and connectivity for wildlife between islands of remaining habitat. Existing informal trails provide views over the downtown L.A. skyline and coast. MRCA will manage the property for conservation and recreation. The project provides enhanced mitigation for the impacts of the construction of the I-405 Sepulveda Pass Widening Project.
- The Trust for Public Land will acquire in-fee the 110-acre Martha Property near the tip of the Tiburon Peninsula. The property offers irreplaceable panoramic views of the San Francisco Bay Area; well-established social trails and wildlife corridors; native grassland, and wetland habitats that support five special status species. The project will permanently prevent development and protect, in perpetuity, coastal live oak woodland, freshwater wetland, and California red-legged frog upland habitat. The community has been working to protect the property for more than three decades. Ownership will be transferred to Marin County Open Space District for management as a public open space preserve. The project provides enhanced mitigation for the construction impacts of adding two carpool lanes on 16-miles of the US101 Marin Sonoma Narrows related transportation facility.
