Subject: Adoption of the FY 2025-26 Road Maintenance and Rehabilitation Account, Local Streets and Roads Funding Initial Report of Eligible Cities and Counties, Resolution G-25-56

Recommendation:

Staff recommends the California Transportation Commission (Commission) adopt the Fiscal Year 2025-26 Road Maintenance and Rehabilitation Account, Local Streets and Roads Funding Initial Report of Eligible Cities and Counties (Initial Report) as provided in Attachment B, and direct staff to transmit the list of eligible jurisdictions to the State Controller (Controller).

<u>lssue:</u>

Cities and counties are estimated to receive approximately \$1.7 billion in Road Maintenance and Rehabilitation Account, Local Streets and Roads funds through monthly disbursements from the Controller in Fiscal Year 2025-26. The Commission must submit an Initial Report of eligible cities and counties to the Controller by August 31, 2025. Eligible cities and counties will then begin receiving monthly disbursements from the Controller in September 2025.

To be included in the Initial Report, jurisdictions must adopt, by voted resolution, a list of projects expected to be funded with the fiscal year program funds for which eligibility is sought. The project list and resolution must have been adopted by a city or county and submitted to the Commission by July 1, 2025. Program statute and the Local Streets and Roads Funding Program Guidelines require each project on a city or county's list to include a project's description, location detail, useful life, and delivery schedule.

By July 1, 2025, 525 out of 540 jurisdictions submitted the required resolution and project list detail to the Commission. The 525 jurisdictions (468 cities and 57 counties) deemed eligible for funding are identified in the Initial Report (Attachment B).

Commission staff confirmed that the remaining county, and all remaining cities, intend to seek subsequent funding eligibility by September 2025. For a period of 90 days, the Controller will

retain apportionment amounts for the one remaining county, and fourteen remaining cities. Commission staff will continue to work with these jurisdictions to ensure timely and complete submittals for subsequent eligibility as provided in Attachment B. Consistent with the Local Streets and Roads Funding Program Reporting Guidelines, complete submittals received after the initial July 1, 2025, deadline, but on or before September 30, 2025, will be recommended for adoption at the October 2025 Commission meeting.

Any submittals received after September 30, 2025, will not be included in the subsequent eligibility list for Fiscal Year 2025-26, and therefore those jurisdictions would not receive monthly disbursements for the fiscal year. The Controller would recalculate and disburse those forfeited funds by existing formula amongst jurisdictions that were deemed eligible for Fiscal Year 2025-26 funding.

Background:

On April 28, 2017, Governor Brown signed Senate Bill (SB) 1 (Beall, Chapter 5, Statutes of 2017). A percentage of the Road Maintenance and Rehabilitation Account funding created by SB 1 is apportioned by formula and disbursed monthly by the Controller's Office to eligible cities and counties pursuant to Streets and Highways Code Section 2032(h) for basic road maintenance, rehabilitation, and critical safety projects on the local streets and roads system.

Pursuant to Streets and Highways Code Section 2034 and the Local Streets and Roads Funding Program Reporting Guidelines, a list of projects adopted by resolution must be submitted to the Commission each year for jurisdictions to be included in the initial eligibility report presented to the Commission for consideration.

Cities and counties that receive fiscal year program funds are required to submit an expenditure report to the Commission each year. Fiscal Year 2024-25 Expenditure Reports are due to the Commission by December 1, 2025, to account for all program funds received and spent in the fiscal year.

- 1.1 **WHEREAS**, on April 28, 2017, Governor Brown signed Senate Bill (SB) 1 (Beall, Chapter 5, Statutes of 2017), known as the Road Repair and Accountability Act of 2017 to address basic road maintenance, rehabilitation, and critical safety needs on both the state highway and local streets and road system; and
- 1.2 WHEREAS, beginning November 1, 2017, portions of new funding from increases to certain fuel excise and sales taxes and vehicle registration fees were deposited into the Road Maintenance and Rehabilitation Account, and a percentage of this new funding is apportioned monthly by formula by the State Controller, pursuant to paragraph (2) of subdivision (h) of Section 2032 of the Streets and Highways Code, to eligible cities and counties for basic road maintenance, rehabilitation, and critical safety projects on local streets and roads; and
- 1.3 **WHEREAS**, Streets and Highways Code Section 2034(a)(1) requires that prior to receiving an apportionment of Road Maintenance and Rehabilitation Account funds in a fiscal year, an eligible city or county shall submit to the California Transportation Commission (Commission) a list of projects proposed to be funded with these funds pursuant to an adopted resolution; and
- 1.4 **WHEREAS**, Streets and Highways Code Section 2034(a)(2) requires that the Commission report to the State Controller the cities and counties that have submitted a list of projects as described in this subdivision and that are therefore eligible to receive an apportionment of funds under the program for the applicable fiscal year. The State Controller, upon receipt of the report, shall apportion funds to eligible cities and counties; and
- 1.5 **WHEREAS**, Streets and Highways Code Section 2034(a)(1) specifies that the project list shall not limit the flexibility of an eligible city or county to fund projects in accordance with local needs and priorities, so long as the projects are consistent with Streets and Highways Code Section 2030(b); and

- WHEREAS, the Commission, in consultation with cities, counties, and their representatives as well as the State Controller's Office and other stakeholders, developed the Local Streets and Roads Funding Program Annual Reporting Guidelines adopted by the Commission on March 24, 2021, revising the detail and process for the project list submittal and project expenditure reporting; and
- 1.7 **WHEREAS**, Commission staff collected the Fiscal Year 2025-26 project list resolution submittals from cities and counties as required by Streets and Highways Code Section 2034(a)(1); and
- 1.8 **WHEREAS**, While Commission staff (pursuant to Streets and Highways Code Section 2034(a)(1)) reviewed submittals for completeness, Commission staff did not select or recommend the projects listed; and
- 1.9 **WHEREAS**, Commission staff compiled a list of cities and counties that provided complete project list resolution submittals and those jurisdictions are therefore eligible to receive Fiscal Year 2025-26 formula apportionments of Road Maintenance and Rehabilitation Account, Local Streets and Roads Funding, as reflected in the Initial Report of Eligible Cities and Counties (Attachment B); and
- 1.10 **WHEREAS**, Attachment B is intended to serve as the initial report of eligible cities and counties as required by Streets and Highways Code Section 2034(a)(2), for transmittal to the State Controller.
- 2.1 **NOW, THEREFORE, BE IT RESOLVED,** that the Commission adopts the Fiscal Year 2025-26 Road Maintenance and Rehabilitation Account, Local Streets and Roads Funding Initial Report of Eligible Cities and Counties; and
- 2.2 **BE IT FURTHER RESOLVED**, that Commission staff is authorized to make minor technical changes as needed to the report; and
- 2.3 **BE IT FURTHER RESOLVED**, that the Commission directs staff to transmit the report to the State Controller as required by Streets and Highways Code Section 2034(a)(2).
