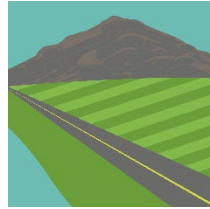

Fact Sheet – Tehama County 2024 RTIP

Dear Mr. Keever:

The Tehama County Local Transportation Commission is submitting the 2024 Regional Transportation Improvement Program **Fact Sheet**. The following facts are true regarding this submittal:

A. Executive Summary

The Tehama County Local Transportation Commission (TCTC) adopted the Regional Transportation Improvement Program (RTIP) on December 4, 2023. This RTIP is outlined to program capital funds for projects identified in the current Regional Transportation Plan.

B. Tehama County requests the following projects be programmed in the 2024 STIP:

City of Tehama. - PPNO 2599 	<ul style="list-style-type: none"> - This project constructs a section of new roadway off B Street to provide access to City parcels and improve circulation on the north side of the City of Tehama. 	\$1,000,000
<ul style="list-style-type: none"> - C Street Traffic Calming and Safety Project 	<ul style="list-style-type: none"> - Traffic calming and pedestrian safety improvements in the City of Tehama on the City's main street which sees regional traffic in this small community. 	\$840,000
