






Trucks Are Essential to the Economy


Trucks Are Essential to the Economy




Figure 1: Distribution of Industry Issue Prioritization Scores

Hours of Service/ELDs

- Federal safety rules mandate breaks
 - No more than 11hrs driving during total of 14hr on-duty cycle. Must take 10hrs off-duty to re-start.
 - No more than 8hrs between 30 min breaks
- State labor and employment laws mandate meal and rest breaks
 - In California, must provide 10-min paid break every 4hrs, at least 30-min unpaid off-duty meal break for every 5hrs worked.

Drivers must take breaks!

- Transition to electronic logging devices (ELDs) from paper logs
 - 3-7% impact on capacity (Source: ACT Research)

Infrastructure Investment/Congestion

- ATRI Top 100 Freight Bottlenecks
 - CA 7 including 5 in Top 50 worst
 - WA 6 including 1 in Top 50 worst
 - OR 1
- Freight demand forecasted to increase by 50% between 2012-2045 (Source: 2016 FHWA Freight Analysis Framework)
- <u>Congestion + Lack of Parking + Hours of Service +</u> <u>Driver Shortage</u>
- <u>Needed Investment in Infrastructure and Planning</u> <u>to Accommodate Forecasted Growth</u>
