

Emergency Opening (EO) Projects

- Caltrans has been inundated with EO Projects to restore essential travel.
 - EO costs are initially deducted from SHOPP capacity.
 - As the Federal Highway Administration approves storm damage claims, SHOPP capacity is restored to previous levels.
- Approximately \$552 million in EO projects are funded with SHOPP capacity as of May 9, 2017.

Caltrans is pursuing Federal approvals.



Senate Bill (SB) 1 Overview

- SB 1 was signed by Governor Brown on April 28, 2017.
 - Expected to raise over \$52.4 billion in transportation revenue over 10-years; approximately \$5.2 billion available annually.
- Increased revenue sources:
 - Gasoline Excise Tax (Nov. 2017)
 - Diesel Excise Tax (Nov. 2017)
 - Diesel Sales Tax (Nov. 2017)
 - New Transportation Improvement Fee (Jan. 2018)
 - New Zero Emission Vehicle fees and accelerated loan repayments
- All taxes and fee increases are permanent and indexed for inflation growth.
